Dear Ms Ramcharan;

The Nunavut Water Board ("NWB") would like to acknowledge receipt on January 30, 2008 of the above Plan submitted as additional information with the recent Amendment application. The recent technical review that was carried out concurrent with the 3rd Amendment application has identified several items that are to be considered for future revisions.

These items include the following:

- o A Table of Contents is helpful to demonstrate the layout of the Plan;
- o Unless otherwise indicated or clarified, the Plan should be titled with both Licensees and include complete contact information for Licensees and indicate their responsibility under the Plan;
- o Proper reference to INAC (Indian and Northern Affairs Canada);
- O A map has been included within the Plan, however a more detailed map, appropriately scaled to indicate camp location and components of the camp, setting and location in relation to sensitive water resources and environmental habitat, Fuel caches and fuel tanks, transportation links including airstrip and helipads and emergency response equipment and supplies. Typical topographical maps can be used where site specific mapping has not yet been completed. Separate maps may be required; and
- o Reference is made within the Plan to activities that extend beyond the current Water Licence expiry date. This information should be clarified within the Plan or removed;

Currently, there is no requirement for an Approval of the Board for the Plan under Licence 2BE-RBP0608, and as such the NWB has acknowledged the receipt of the Plan as per Part H, Item 1 of the Licence. The NWB requests that the Licensee provide an updated Abandonment and Restoration Plan within thirty (30) days of issuance of this letter, or within an Application for Renewal of Licence 2BE-RBP0608, whichever occurs first, for approval of the Board in writing.
