Hello Candace

I have looked over the previous amendment again and I must stress that the requirement for a stand-alone document summarizing Areva's drilling procedures must be submitted as a requirement under amendment #3. This is because the summary of drilling procedures must go out for comments from interested parties and entities. The reason the NWB is requesting this document is because during the most recent INAC inspection the inspector noted that Areva was not following the procedures that were submitted with the licence application. The inspector also noted that drill water and drill wastes were not being contained in sumps but spilled onto surrounding lands.

The NWB recommends that the drilling procedures summary be submitted as soon as possible and that it address all the concerns documented by the INAC inspector. As stated in amendment #3 a summary of drill procedures must be provided before the renewal of the licence.
