## LICENCE AMENDMENT No. 1

Pursuant to its authority under Article 13 of the Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada and the Nunavut Waters and the Nunavut Surface Rights Tribunal Act, the Nunavut Water Board hereby grants the following license amendment.

The License issued May 23, 2006 with a licence expiry date of August 31, 2008 shall be amended to include the following terms and conditions, with respect to use of water and deposit of waste during camp and drilling operations, to allow Roche Bay plc to allow for support of exploration drilling in the Qikiqtani Region contained within the general Latitudes 68°15'-68°30'N, 82°00'-84°00'W.

The licence shall be amended to include:

## PART D: CONDITIONS APPLYING TO WASTE DISPOSAL

Insert Item 6 The Licensee shall provide to the Board and to the Inspector, documented authorization from the community of Hall Beach for use of their community landfill prior to the backhauling of any waste.

## <u>PART F:</u> <u>CONDITIONS APPLYING TO DRILLING OPERATIONS</u>

Insert Item 5 On-ice drilling is not permitted under this Licence.

## PART G: CONDITIONS APPLYING TO SPILL CONTINGENCY PLANNING

The Plan under Part G is to be revised as per Part G, Item 2 to include the new information on the Joint Venture and indicate the Operating Company and contact personnel. The Plan shall be revised to meet Part G, Item 1.

Recommended revisions include, but are not limited to the following:

Update the facility location map indicating the final camp location once layout is decided. The map should be topographical and of a suitable scale to include all facilities, nearby bodies of water and drainage patterns.

Page 11, Action Plans, incorrectly states that the Spill Line will provide direction on clean-up and disposal instructions. It is the Licensee that is required to develop appropriate plans to address response, clean-up and disposal.

In addition to the requirements of Part G, Item 1, the Plan shall be revised to indicate the immediate notification of the Inspector at 867.975.4298 upon reporting of the Spill to the NWT/NU Spill Report Line.

A revised Spill Report Form is available from GN-DOE or at the NWB ftp site. This form should be updated with the revision.

All remaining terms and conditions of the License 2BE-RBP0608 Type 'B" dated May 23, 2006 still apply.
