Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and the Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following licence amendment.

The Licence issued May 23, 2006 with a licence expiry date of August 31, 2008 shall be amended to include the following terms and conditions, with respect to use of water and deposit of waste during camp and drilling operations, to allow Roche Bay plc and Advance Explorations Inc. for support of exploration drilling activities in the Qikiqtani Region, contained within the general Latitudes 68°15'-68°30'N and longitudes 82°00'-84°00'W.

### **PART D: CONDITIONS APPLYING TO WATER USE**

Amend Item 1     The Licensee shall obtain water for domestic camp use from the lake within close proximity to the camp, up to a maximum of 5 cubic metres per day. Drill water shall be obtained from local water source(s), proximal to the drilling targets as outlined in the application up to a maximum of 195 cubic meters per day. Total water use, for all purposes, shall not exceed 200cubic metres per day.

### **PART G: CONDITIONS APPLYING TO SPILL CONTINGENCY PLANNING**

In addition to the revisions requested within Amendment No.1, issued May 16, 2007, additional revisions shall include the following:

- i.     Recommendations within the Env. Can. review of application response letter of August 22, 2007;
- ii.    The Inspector should be notified at 867-975-4295 immediately after reporting a spill to the Spill Report Line;
- iii.   An updated, revised contact list to include the INAC Manager of Field Operations at 867-975-4295, the Environment Canada, EP 24hr monitored emergency pager at 867-766-3737; and
- iv.    The Licensee should consider keeping the contact information more readily accessible within the main document rather than after the Product information section where it might be more easily found.

**All remaining terms and conditions of the Licence 2BE-RBP0608 Type 'B' dated May 23, 2006 and the Amendment No. 1, issued May 16, 2007 still apply.**
