**RE: SUMMER 1998 DRILL PROGRAMME: ROCKINGHORSE PERMIT -**  
**I96C096 and INAC PERMIT N97C696**

This is to advise you that drilling under the above programme commenced on 20 July, 1998, which event coincided with your visit to the Monopros camp. The target completed was **RHL98ADAT04-01**, which is located on Crown Land in NTS 76E/13. (Please refer to accompanying map for locations of all proposed drillsites.)

It is likely that not all of the 17 selected targets will be drilled, but that an additional hole may be drilled at the **Muskox** site.

As of now, a second hole whose ID is **RHL98HSG14-1** (one of three expected targets on claims within IOL) has been completed. The drill has only just moved to the third drillsite, at **RHL98HSG17-01**, north of the IOL boundary line.
