## RE: APPLICATION: NEW "CLASS A" LAND-USE PERMIT TO REPLACE #N2000C0021 (Rockinghorse Property)

Please accept this letter and the accompanying application as a formal request for a new Class A Land-Use Permit to replace #N2000C0021, which expires on 12 March 2003. As a ground geophysical programme (preparatory to core drilling) is planned to commence on or about 15 March, timely processing of this application would be much appreciated. A cheque in the amount of \$450.00 is attached to cover application fees and land-access fees for use of up to six hectares of Crown land on the Koamaogaktok/Napaktulik (Rockinghorse) property.

The De Beers Canada Exploration (DBCE) Rockinghorse Project has been ongoing since the mid-1990s; some claims are being allowed to lapse, 34 claims on Crown land have been surveyed in order to be taken to lease and a total of 34 new adjacent claims bordering Napaktulik Lake were staked in November 2001 and will be the focus of a till-sampling programme in summer 2003. Activities planned for spring 2003 include diamond core drilling of up to 8 holes on Crown land and drilling of approximately 10 holes into the *Muskox* kimberlite on IOL land. Drill programmes (between April and May 2003), as well as summer till sampling, will be supported from the existing tent camp located on claim *TL 91* on surface-rights Inuit parcel #CO-05. Although the Project remains mainly air-supported, a temporary push-in trail, proceeding west and north from the Lupin winter road to Rockinghorse camp, may be used twice during the drilling season in order mobilise and demobilise drills.
