**Re: Additional Information Required for Western Uranium Corp.'s "Thelon Basin" Project Proposal**

Dear Mr. Bowden:

On February 17, 2009 the Nunavut Impact Review Board (NIRB or Board) was forwarded an application for a one year extension to land use permit N2006C0041 from Indian and Northern Affairs Canada (INAC), in association with Western Uranium Corp.'s (Western Uranium) "Thelon Basin" project proposal (NIRB File No. **07EN005**). On March 2, 2009 NIRB received confirmation from the Nunavut Planning Commission that the previous conformity determination (Keewatin Regional Land use Plan) still applies to the current project proposal.

After conducting a preliminary completeness check, on March 2, 2009 NIRB requested additional information from Western Uranium to permit proper screening of this project proposal. It was requested that the following information be provided to NIRB on or before March 16, 2009:

- NIRB Part 1 Form in English and Inuktitut (*attached*)
- Non-technical project proposal summary in English and Inuktitut

To date, the Board has not received the requested information for this file. NIRB is again requesting submission of the above information on or before **March 25, 2009**.

Please be advised that it is in Western Uranium's best interest to cure the above deficiencies in a timely manner. Failure to address the deficiencies before NIRB resumes the screening process may result in the "Thelon Basin" project proposal being returned for clarification in accordance with Section 12.4.4 (c) of the Nunavut Land Claims Agreement. If Western Uranium determines that the time required to cure the deficiencies is significantly greater than 1 week, NIRB advises that it consider canceling its current application with INAC and NIRB and re-filing its project proposal with the requested information.

If Western Uranium determines that the deficiencies can be cured within a reasonable time period, NIRB advises it notify the Board on or before **March 25, 2009**. If no further information or notification is received by NIRB after this date, the Board shall resume the screening process for this file.
