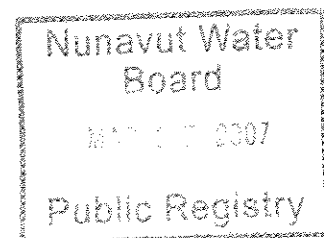


General Summary – Forum Uranium Corp./Superior Diamonds Joint Venture
Proposed activities in the Kiggavik area

Forum Uranium Corp. (“Forum”) is a Vancouver-based energy company committed to the exploration and development of uranium resources in Canada. Forum’s activity has previously been focused on Saskatchewan’s Athabasca Basin, where their holdings exceed 180,000 hectares. The geological similarity between the Athabasca and Thelon Basins has prompted Forum and joint venture partner Superior Diamonds Inc. (“Superior”) to undertake exploration activity for uranium on almost 100,000 hectares in the Schultz Lake area west of Baker Lake, Nunavut.

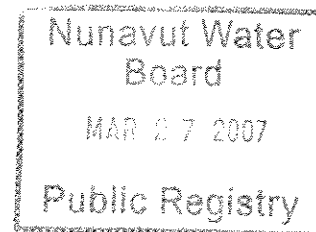
Over the next two years, Forum and Superior propose a two-stage exploration program in the Kiggavik area. The 2007 summer field season will involve geological mapping, prospecting, and sampling, as well as airborne and ground-based geophysical surveys. If preliminary results are encouraging, Forum and Superior will advance to the next stage in 2008; this could involve the abovementioned activities as well as diamond drilling and surface trenching. No drilling or trenching is scheduled for the summer of 2007.

Forum and Superior are committed to the social and economic development of the North, and look forward to working closely with the people of Baker Lake. Whenever possible, we will hire local personnel as prospectors, camp attendants, or field assistants to geology and/or geophysical crews. We will also make use of competitively-priced local services. Forum and Superior respect the traditional way of life of aboriginal peoples in the North; we will take every precaution to avoid disturbing wildlife and habitat, environmentally sensitive areas, and sites of cultural significance in the region. We propose to consult regularly with the hamlet of Baker Lake in order to keep the community informed of our activities and to address any concerns the community may have regarding our presence in the area. Forum and Superior are committed to working with the people of Nunavut towards a mutually beneficial future.

Summary of Proposed Work – Kiggavik Area

1. Location & Access

Claim blocks held by Forum Uranium Corp. (hereafter referred to as “Forum” or “the company”) and Superior Diamonds Inc. (“Superior”) comprise an area of approximately 95,862 hectares, located 75 to 100 km west to northwest of Baker Lake, Nunavut (see Figure 1; General Location Map). The claims cover a discontinuous area ranging from Latitude N 64° 07' 28.6" to Latitude N 64° 44' 20.5" and from Longitude W 96° 21' 22.5" to Longitude W 98° 06' 43.9". Forum claims occur within NTS map sheets 66A04, 05, 06, 07, 09, 10, 11, 12; and NTS 66B01 & 08. Many of the company's claims in the area south of Schultz Lake occur within the boundaries of Inuit Owned Surface Land parcel BL-19. The field area is accessible by helicopter and float plane during the summer months; in winter the area is accessible by aircraft and snow machine.

2. Proposed Activities

Over the next two years, Forum/Superior proposes to undertake a two-stage exploration program in the Kiggavik area. The 2007 field season will encompass prospecting, rock and soil/till sampling, geological mapping, and airborne and grid-based ground geophysics. The proposed limits of airborne reconnaissance are indicated in Figure 1; high-priority areas for ground geophysics and/or drilling are also outlined, though no drilling is scheduled for the summer of 2007. If preliminary results are encouraging, the project will advance to the next stage in 2008, which could involve the abovementioned activities as well as diamond drilling and surface trenching. Drill locations are unknown at the moment and permitting for drilling will likely commence in September 2007, once the summer program is complete.

The winter months of 2007 will involve establishment of fuel caches at several locations around the field area. Please see Figure 1 for proposed cache locations (red squares); geographic coordinates and fuel type/quantity are recorded in Table 1 below. The remainder of the company's fuel will be stored in Baker Lake in a location that is easily accessible to the helicopter's flight and ground crews.
