Good morning Tony,

A couple of quick questions:

The section 25 of Renewal Application indicates proposed term of Licence: **5 years** for the requested Renewal **Issuance in August 2013** and **Expiry date August 2018**. Just for your information: if/when the Licence is renewed it would be from issuance date in 2014. So i guess it would be for 5 years to expire in 2019? Do you concur with this?

It seems a new Camp is required for the renewal licence. Please be advised that a Remote Camp Questionnaire should also be completed and included within the application.

Also, for Uranium exploration projects the NWB generally requires an Uranium Exploration Plan that addresses environmental and water issues related to exploration, drilling, extraction, storage and remediation, and also covering the personal safety, exploration and drilling procedures, reclamation, and monitoring (Part F, Item 1 of expired 2BE-SCH0712 licence).

The Board will be sending the renewal application for public review once these documents are included within the application package.
