Good Afternoon Ken, Matt and Rick,

I want to inquire about Forum Uranium's Judge Camp, Judge Sissons Lake, Kivalliq Region, Nunavut.

During 2012 an inspection was completed of the Judge Camp though it was not active and not covered under this Water Licence. The Inspector specifically referenced the expiry -of the Water Licence and the Land Use Permit which authorizes the fuel storage- as an issue.

Though the project is not in operation Forum is still require to report to the Nunavut Water Board, pay outstanding water use fees, renew/amend the water licence and maintain appropriate authorization to cover the entire scoop of the project.

I have attached a copy of your Water Licence for your convenience. I remind you that Forum Uranium Corp. is bound by all the terms and condition of this water licence regardless the expiry.

Please provide a written update as this site has been tentatively scheduled for inspection this year. I can be reached by phone 867 975 4296 for assistance or discussion.
