The company is North Arrow Minerals Inc. and Gord Clark, the gentleman who called you, is the president and CEO.

On May 9, 2007 a plan of arrangement was completed, under which the exploration assets of Strongbow Exploration Inc. ("Strongbow") were re-organized, and its interests in certain of its northern exploration properties were transferred to North Arrow Minerals Inc. ("North Arrow"). At the time the plan of arrangement was completed on May 9, North Arrow was a wholly owned subsidiary of Strongbow. Subsequently Strongbow has distributed a portion of its North Arrow shares to its shareholders and the shares of North Arrow have been listed on the TSX Venture Exchange.

The mineral dispositions that comprise the Silvertip project are not included in the re-organization described above, however they are subject to an option agreement between North Arrow and Strongbow, with North Arrow being the operator of the project.

It is my understanding that NWB License 2BE-SIL0709 will stay in Strongbow's name at this time.

I will be contacting you in the future regarding the possible assignment of other licenses to North Arrow that are currently held in Strongbow's name.
