***This license expired on May 31, 2009. Abandonment and reclamation activities on the land use area have been completed.***

**8. ABANDONMENT MEASURES**

***The abandonment and restoration activities completed on the land use area subject to this license were detailed in a letter submitted to the Nunavut Water Board on June 24, 2013.***

On August 11, 2011 the Resource Management Officer for the Kitikmeot Region conducted a final inspection of the camp location. A copy of the inspection report and the official closure letter issued by INAC was included in the aforementioned correspondence dated June 24, 2013.***

***Land use for the portion of the project located on Inuit Owned Land parcels was authorized by the Kitikmeot Inuit Association under Inuit Owned Land Use License 3, KTL307C006. A final inspection has been conducted by the Kitikmeot Inuit Association on the land use area subject to this authorization and final closure of this license has been granted.***
