## **ENGAGEMENT SUMMARY**

Dialogue with landowners, Indigenous Governments rights holders and interested parties regarding the South Kitikmeot Gold Project specific to the land use permit, land use licence and water licence applications commenced in late September. Parties engaged include:

- Adjacent interest holders;
- Akaitcho Dene First Nations Interim Measures Office (ADFNIMO);
- Canadian Northern Economic Development Agency (CANNOR);
- Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC);
- Government of the Nunavut (GN);
- Hamlet of Kugluktuk;
- Kitikmeot Inuit Association (KIA);
- Kugluktuk Angoniatit Association (KAA);
- Nunavut Water Board (NWB);
- Tłycho Government (TG).

## At the time of application submission:

- Virtual or in person meetings were held with CIRNAC, CANNOR, GN and TG;
- Hamlet of Kugluktuk presented project materials to council;
- Inspector provided direction on enforcement of expected conditions applying to caribou protection;
- In person meetings and a public meeting are planned in Kugluktuk early in 2023;
- Proposed caribou protection measures have been widely circulated and feedback requested;
- Planning for coordination with adjacent projects commenced;
- Aurora Geosciences Ltd. on behalf of Viridis Mining and Minerals is not aware of any outstanding issues.
