Hi Bruce:

The Nunavut Water Board (NWB or Board) is at the final stages of its review process for the above-mentioned application. However, two items have been identified, which the Licensee must address before the NWB could issue a decision on the application:

- Absence of annual reports for the project for the period 2013-2015 or confirmation from the Licensee indicating that no work was undertaken over the same period; and
- Absence of an addendum to the March 24, 2009 Plan entitle "Slave Project: Abandonment and Decommissioning Plan, in the Contwoyto Lake and Hood River (Penthouse Lake) Areas, Nunavut" as required under Part I, Item 2 of Licence No. 2BE-SLA0814.

Based on information included in the cancellation application submitted in 2012, the NWB understands that no work was carried out for the project over the period preceding submission of the application. It should be noted, however, that before the NWB could issue its decision with respect to the application, all outstanding requirements associated with the licence have to be addressed.
