Background

The Slave Project never got off the ground. That is to say, there was never any camp set-up, water use or deposit of wastes of any kind with respect to this project and water license #2BE-SLA0814.

All previous annual reports were found to be satisfactory and complete in meeting the requirements of water license 2BE-SLA0814.

Recommendations/Comments

AANDC notes that in Block 3 of the cancellation application it is stated that the licensee is Golden River Resources Corporation; this is the only time that AANDC has seen this company name for water license 2BE-SLA0814 and can find no other reference to this company name. Therefore AANDC recommends clarification as to proper name of the licensee. In looking through all past reports generated by the licensee, it is stated that the company name is Golden Bull Resources Corporation. Furthermore the water license is also in the name of Golden Bull Resources Corporation.

The Water Resources Division of AANDC recommends that the above referenced licence not be cancelled/ closed until a Water Resource Officer and/or Resource Management Officer from the Field Operations Division of AANDC provides confirmation that no compliance issues are associated and outstanding with the project.
