- 1) 1BR-MAC0712 falls outside an approved LUP boundary, therefore no CD required by NPC - appears to be 12-1 exempt
- 2) 1BR-RAN project proposal will not have significant affects/impact outside the Hamlet boundary therefore no CD required. - as noted in your letter to distribution, the NIRB completed screening of this file May 15/08 under file # 08UN029
- 3) 2BE BOR - currently being reviewed for conformity - **I believe this is for the same proposal we are currently reviewing for INAC and QIA**
