The Nunavut Water Board (“NWB”) acknowledges receipt, on April 14, 2010, of a new application for a Type “B” water license for water use and waste disposal associated with exploration activities in the Qikiqtani region of Nunavut. The application consists of the following documents:

However, the NWB retains the right to request additional information and studies pursuant to sections 48(2) of the Act or to issue guidelines for the provision of information pursuant to section 48(3) of the Act. A NWB Technical Advisor may be in touch with you to clarify any technical details related to your application.

To ensure this application is dealt with in a timely fashion, the NWB forwards notice of all documentation to regulators and council of the municipality(ies) most affected by the project, inviting interested parties to make representation directly to the NWB *within 30 days from the date of this letter.* The NWB may provide additional procedural instructions once the application has been reviewed by interested parties.
