The Nunavut Water Board acknowledges receipt of your notice. The water licence 2BE-STO2025 expires August 16, 2025: "Note that if the Licence expires before the NWB issues a new one, then the use of Water and deposit of Waste must cease, or the Licensee may be in contravention of the Nunavut Agreement and the Nunavut Waters and Nunavut Surface Rights Tribunal Act (NWNSRTA). However, the expiry or cancellation of a licence does not relieve the holder from any obligations imposed by the licence. The NWB recommends that an application for the renewal of this Licence be filed at least three (3) months prior to the Licence expiry date."
