The Nunavut Water Board received an amendment application for the Tahoe Lake Project from Major General Resources, for the establishment of a secondary campsite. The application included the following items:

This project is currently under review and will be screened by the Nunavut Impact Review Board for their determination as to whether they require further review, or if it can be processed by the Nunavut Water Board. Notice of this application is required, based on Article 13.3.14 of the Nunavut Land Claims Agreement (NLCA), which states that the Board should take "...all steps necessary by way of notice...to provide and promote public awareness [of hearings]." Accordingly, the enclosed notice in both English and Inuinaqtun has been posted for a period of 30 days, with the following establishments in Cambridge Bay:- Hamlet Office, KIA & CLARC, HTO, Northern Store and Co-op Store.

Upon request from the public, we ask you to make available, free of charge, copies of all documents pertaining to this application. Any person who is affected by this application or concerned with it, may submit a letter of concern, which must be submitted to the Board within 30 days from the date shown on this letter.
