The Nunavut Water Board ("NWB") would like to acknowledge the receipt of the above document under Part G, Item 1 of Licence NWB2TAH0406. The Abandonment and Restoration Plan was distributed upon receipt for review and comment to interested persons with a submission deadline of December 22, 2005. There were no comments received from interested persons with respect to the submission.

The technical review of the Abandonment and Restoration Plan has been completed. The Board has taken into consideration the information submitted and hereby accepts and *conditionally* approves the Abandonment and Restoration Plan under **Motion 2005-33**, dated **February 13, 2006**.

The NWB requests that Diamonds North Resources Ltd. revise and submit the Abandonment and Reclamation Plan within sixty (60) days to reflect the current project status and the recent renewal application received by the NWB.

Under a separate email notification dated January 11, 2006, Diamonds North Resources Ltd. was requested to revise the Plan, and that it is to be included within the application documents. A number of recommendations were provided and are summarized in Attachment No.1. The NWB looks forward to receiving the revised submission to be included in the renewal application review.

## ATTACHMENT NO.1

In addition to the information presented in the current Abandonment and Restoration Plan, the revised A&R Plan should include, but not be limited to the following:

- 1) a preparation date and who prepared the document as well as contact information for the person responsible for Environmental matters within the Company;
- 2) a table of contents;
- 3) the effective period of the submitted plan will expire with the Licence, this timeframe should reflect the current application period (ie 06March to 08March);
- 4) a reference map should be included with the Plan, showing both locations and details, a suitable scale to indicate topographic changes, nearby water resources and sensitive areas;
- 5) Maps should include lats and longs; within the site/facility description, the lats and longs should be included, only the NAD83 coordinates are given;
- 6) a short discussion on other regulatory instruments in place is to be included, land use permits for all activities;
- 7) combustible waste was discussed, however the disposal of remaining ashes was not included. Handling of non-combustible waste is not discussed;
- 8) the project discusses the use of an esker for the purpose of moving supplies and personnel, this item needs to be addressed within the plan as well as any access route (if used) from the camp to the landing strip;
- 9) under the section on "contamination and cleanup", information should be included with respect to the "approved" location for the disposal of contaminated materials and the approval that has been obtained; and
- 10) Under "documentation and inspection" the photographic record should include photos before, during and after the project comes to a close.
