Dear Paul Sobie,

The Nunavut Water Board has completed the preliminary technical review of the water licence application by MPH Consulting Limited.

Below please find several requests for clarification:

1. Box 1 of the application form lists MPH Consulting Limited as the applicant. However, within the application package, a letter from 1237719 B.C. Ltd is included denoting MPH as the representative for the purposes of water licence application. We request that you kindly clarify who the applicant is.
2. The Henik Lake camp is explicitly stated as excluded from the application, although the intent for its winterization and camp description are included within the management plans and other application documents. The Board could not place a valid licence that authorizes the Henik Lake camp operation. Could you please clarify whether MPH holds a water licence to operate the camp? Please note that some activities (such as types of waste disposal and water use) noted in the application relate to camp operation.
3. The water withdrawal rates from Henik Lake for camp purposes are also listed in Box 13 of the application form. Does MPH seek the Board's authorization for this type of water use?
4. In Box 15 of the application form, the composition of greywater is "drill water". Could you please clarify which of the two it is?
5. The Board thanks the applicant for submitting the wildlife management plan and the safety manual; however, the contents of these documents are outside of the Board's mandate. The NWB recommends MPH withdraw these to reduce the workload of the interveners during public review.
6. Although Box 15 of the application form does not mention incineration, the ENVIRONMENTAL MANAGEMENT PLAN states some waste is intended to be incinerated. Could you please provide the incinerator management plan? Alternatively, a manufacturer's manual would also work as long as it has all information to satisfy ECCC's Technical Document for Batch Waste Incineration (January 2010) and Government of Nunavut's Guideline for Burning and Incineration of Solid Waste.

7. Could you please provide a searchable version of the application form.
