As we have discussed before, there will be no exploration on the ground by Mega Uranium in 2013 since the claims and lease are now owed by NEXGEN Energy. The only work we intend on carrying out is removal of the existing fuel and camp at Itza. Once we have confirmed dates with contractors we can send you the summary of actionable items within the A and R plan and implementation schedule.
