Hi Phyllis,

Deborah has sent me a table of coordinates, unfortunately, I have not been able to use them in the format given. I've been looking for a way to import the coordinates but have not had sufficient time to find a solution. Deborah, sorry I haven't had a chance to get back to you on this. I spent a couple days trying to convert the data then got pulled away onto an urgent file. If you are able to send me the coordinates in a manipulable format, I might be able to import them into my software. At minimum a .csv file and I can have my GIS guys import it, but if I can get it in a .gdb or .gpx I can import it directly. Unfortunately, starting with a .pdf, I would have to manually input which I don't have the time to do. It seems likely, however, that I will have to re-do this inspection regardless. Since I was flying without any working coordinates the first time I simply did a pass over the property.
