Thank you for keeping me informed of the recent developments on this file.

I must say that I am not sure, to the fullest extent, of the nature or context of discussion(s) that you and the representative(s) at Dimondex Resources Ltd. (Diamondex) may have had; however, I have attached a copy of the NWB's correspondence that was issued to Diamondex on August the 23, 2013, outlining outstanding NWB requirements, for information purposes.

Based on information contained on the NWB's FTP site, it appears that Dimondex has not responded the NWB's August 23, 2013 correspondence to date.

Further, to address any perceived ambiguity surrounding the administration or the NWB's handling of the file, it should be noted that I am unaware of any cases where NWB's technical staff members have wave requirements to water licences, which are legal documents, by way of a telephone conversation. Only the Board has authority to wave requirements that are embedded in licences.
