Re: Notice of Part 4 Screening for RockGate Capital Corp.'s "Turner Lake" project proposal

Dear Lorne Warner:

On May 1, 2008 the Nunavut Impact Review Board (NIRB or Board) received RockGate Capital Corp's "Turner Lake" project proposal from the Kitikmeot Inuit Association (KIA). NIRB has assigned this project proposal file number 08EN054.

The project is located in the Kitikmeot region, approximately 55 kilometres (km) northwest of the community of Bathurst Inlet and approximately 270 km south southwest of the community of Cambridge Bay. The project is to commence around June 15, 2008 and terminate around August 31, 2008. The 2009 program will be determined after an assessment of the 2008 drill results.

The project activities include:

- Early exploration of gold deposit potential
- Establishment of temporary structure to be used as a core logging building and emergency shelter
- Daily transportation of personal and supplies to drill sites via helicopter from the community of Bathurst Inlet
- Fuel storage at drill sites
- Water use and waste disposal

- Whether the project proposal is likely to arouse significant public concern; and if so, why;
- Whether the project proposal is likely to cause significant adverse eco-systemic and socioeconomic effects; and if so, why;
- Whether the project is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (please provide any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
