Hi Phyllis,

I'm finally getting a chance to get on top of this. Is the inspection report sufficient, with a cover letter stating that I am requesting that the NWB reverse the decision to close the licence based on incomplete information? The LUP inspection was at different coordinates than the Water Licence.

Also, is there any documentation that shows the licence assignment/name change from Golden River Resources to Golden Bull Resources? Lands is in the process of pulling the file from archives, but the LUP closure was sent to Golden Bull, while the water licence is still in the name of Golden River, as far as I can tell. Is there anything you can dig up that isn't on the FTP site? I see in the CWL application (the Combay Federal LUP application) that they state that Golden Bull Resources Corp. is a subsidiary of Golden River Resources Corp.) however, it's not made evident in their articles of incorporation.

If they are the same company, then Golden Bull's closure request for CWL is based on a false claim that "we never went to site".

Hi Phyllis,

I have a question regarding 2BE-WAL0607... is the closure of the licence reversible?

I would advise that the NWB not close any water licences based on past LUP inspections, as often the coordinates given in the two permits are different. As it stands, I was at the WAL0607 site last week because it was also the CWL1116 site, and that licence <u>should not</u> have been closed. But what often happens is the lands inspector has gone to different coordinates and closed the LUP, not knowing there was an associated water licence and other coordinates that should be verified. That may have been what happened in this case; I have not had time to verify with the inspector who recommended the LUP for closure. Until we have a database that cross references the two authorizations, and our officers have access (and utilize) all the information that is available, we are playing a potentially expensive game.

The attached photo is what is on site at the WAL0607 camp - it's a constructed sump or something. I didn't have the tools to pry it open, but there's a wooden box, plastic lined, and plastic piping. This clearly pre-dates the CWL1116 licence, especially as they never stepped foot on site.

I'm not sure how to proceed or what to recommend on this.

Andrew, what are your thoughts?
