Hi Phyllis,

I'm not sure if there has been any movement on this file; just came across it as I was cleaning out my e-mails. Here is some background I had pieced together on the file:

- a licence was issued to Bay Resources in 2004. Activity presumably occurred between 2004 and 2006 but no Annual Reports are found on the NWB registry.
- In 2006 the licensee name changed from Bay Resources to Golden River Resources Corp.
- In 2006 GRR renewed the licence for one year.
- only one annual report is on-file, for 2006.
- no AR was filed for 2007.
- in 2007 Golden Bull Resources applied to renew the licence. In the renewal they provided accurate coordinates of the camp, which were captured in the WRO's database. The comments from INAC at the time required them to prove the relation between Golden River Resources and Golden Bull Resources. They later withdrew the renewal application stating that the site has been remediated and Andrew Keim was contacted to schedule an inspection.
- No Water Licence inspection occurred at that time.
- In 2010 Baba conducted an inspection of the LUP, however, when writing his report he referred to the wrong photographs. He signed off on the LUP and a closure of the LUP ensued in 2011.

- The LUP closure by Brian O'Mara was addressed to Golden Bull Resources Corp.
- In 2011 Golden Bull Resources applied for a new water licence in their own name at the same site. The licence was issued: 2BE-CWL1116.
- In 2012 Golden Bull requested closure of the 2BE-CWL1116 licence stating that they've never stepped foot on site. Field Ops made a priority to do an inspection of the site anyway.
- There is no record on the NWB site of assignment or name change from Golden River (Delaware) to Golden Bull (Australia).
- Golden Bull provided the notice of closure of the LUP to the NWB. Based on that letter (based on a document submitted by a potentially different company regarding an LUP) 2BE-WAL0607 was cancelled (the Licensee is Golden River Resources Corp.).
- Unfortunately, the LUP closure was an irreversible mistake. I'm hoping that the licence cancellation is not irreversible, or that other steps are possible.

I have received no acknowledgement from Mr. Peter Lee on this file. Please let me know what transpires, and what direction the NWB would like us to take.
