The Nunavut Water Board (NWB or Board) has completed its technical review of the 2020 Annual Reports for Water Licences Nos: 2BE-GOT1924, 2BE-GRE1621, 2BE-HUC1823, 2BE-PKR1621, 2BE-PTR1621, and 2BE-WCA1823 provided to the Board on March 31, 2021. Additionally, the NWB reviewed the 2019 Annual Reports for Water Licences Nos: 2BE-WCA1823 and 2BE-HUC1823 submitted on March 13, 2020. Following receipt, all reports were made available through the Kivalliq distribution list for information. No comments have been received to date.

The technical review of the above-mentioned reports determined that the information provided generally addresses the requirements of the respective Water Licences. The Board understands that no exploration activities were conducted in the reporting years under all listed Water Licences, thus no water was used and no waste was generated.

Additionally, the Board notes that the updated Spill Contingency Plan entitled "Amaruq and GOT Exploration Projects Spill Contingency Plan", dated September 2020 (Plan), was provided to the NWB on September 17, 2020. As per the NWB's correspondence¹, dated October 6, 2020, the Plan was approved by the Board in accordance with Motion No. 2020-B1-022.

The Board would also like to remind the Licensee that Water Licenses Nos: 2BE-PTR1621, 2BE-PKR1621 and 2BE-GRE1621 will expire in October 2021. Therefore, a License Renewal process should be initiated at least three months prior to the expiration date, if the Licensee intends to continue working on the respective Projects.
