Review Memorandum

A. BACKGROUND

The Water Resources Division of CIRNAC has undertaken a review of the Bonito Capital Corporation's (BCC) assignment application. The licensee is requesting the assignment of water licence 2BM-ULU1520 to Blue Star Gold Corporation (Blue Star). BCC is a wholly owned subsidiary of Mandalay Resources (Mandalay). The Ulu property is entirely on Inuit owned land.

B. RESULTS OF REVIEW

In reviewing the assignment application, CIRNAC considered the following: security requirements of the licence and recent inspection results.

Security requirements of 2BM-ULU1520

The Minister of CIRNAC currently holds \$1,685,210, however the amount to be held as specified under Part B, Item 2 of water licence 2BM-ULU1520 is \$1,685,542, a difference of \$332.00. CIRNAC expects and Blue Star is required to give security in the amount set out in the water licence (2BM-ULU1520). Therefore security is expected in the amount of \$1,685,542.

CIRNAC holds the position that a property will never be undersecured and will only accept security from the licensee as is set forth in the water licence for that property and licensee. Therefore CIRNAC suggests the following in handling security under the assignment of this water licence:

1) Provided that everything is agreeable, and the Nunavut Water Board (NWB) issues the assignment of the water licence to Blue Star, CIRNAC recommends



- that the NWB issue the assignment with the condition that the assignee (Blue Star) provide security within 30 days of issuance.
- 2) CIRNAC would therefore keep the current security until the receipt and acceptance of new security from the new licensee (Blue Star)
- 3) Upon acceptance of new security from Blue Star, CIRNAC will release and inform the applicable financial institution to cancel security that was previously held in the name of BBC.

Recent Site Visit Summer 2019

A recent site visit to Ulu confirmed that the licensee had completed significant progressive reclamation work at site and as such the land owner (Kitikmeot Inuit Association (KIA)) is only requiring Blue Star to provide an additional \$500,000 under its land lease, down significantly from a previous estimate for the property in 2015.

C. CONCLUSION

CIRNAC has no concerns with the assignment of the water licence to the assignee (Blue Star) as long as security is provided within the timelines stipulated by the water licence.
