The Nunavut Water Board will hold a **public hearing** on the following two applications for renewal:

Location of Projects: a) Lupin Mine, west shore of Contwoyto Lake, Kitikmeot Region
Latitude: 65°46'05'North; Longitude: 111°14'45' West

b) Ulu: Near Contwoyto Lake; Approx. 12 km. North of Hood River
Approx. 155 km. NNE of the Lupin Mine
Latitude: 66°55'; Longitude: 110°58'

Purpose: a) Lupin : Mining, milling and associated camp and logistical operations

These applications have been screened by the Nunavut Impact Review Board pursuant to Section 13.5.1 of the Nunavut Land Claims Agreement. The NIRB determined that the proposals could be processed without a review.

This public hearing will be held on **March 28th and 29th, 2000 in Kugluktuk, Nunavut.**

Pre-Hearings will also be conducted **during the last week of January or the first week of February** in Cambridge Bay, Kugluktuk, Bathurst Inlet, and Umingmaktok (Bay Chimo).

Interventions should be submitted in writing before **March 17, 2000** to the NWB Licence Administrator. The Nunavut Water Board may waive the requirement for a hearing if no public concern is expressed.
