Good morning George,

Thanks for resending the original email. Bit of time getting back to you, quite busy on our end the past few weeks.

I took the time to have a look at the inspection report (requirement to carry out the monitoring program) as well as the licence conditions under Part J and Part I, Item 1. Under Part I, Item 1, is the requirement to submit a Care and Maintenance Plan to the Board for approval. According to what I was able to find in our files, the plan was submitted by Elgin on August 25, 2011 and subsequently distributed for public review and comments. Comments were received from INAC, dated September 30, 2011. According to our files, no further correspondence was issued by the NWB (approval or not) and no further follow-up was received from Elgin. Although the plan does not address the details of monitoring during C&M, INAC did not comment on the monitoring aspects of the C&M Plan. As such, the Inspector's concerns remain in that the monitoring program is still in effect as detailed in Part J. I believe the intent of the condition was to provide the opportunity for the Licensee to provide a plan to address all requirements of the licence that either did not apply or would require modification while in C&M.

In order to amend these requirements (without going through a licence amendment process), I would like to suggest that the C&M Plan be revised and resubmitted to address all monitoring required at the site, indicating a schedule for inspections, deferral of monitoring and reporting requirements during C&M as set out in Part J (10) and schedule J. The plan should also indicate a return to the monitoring/reporting requirements of the Licensee upon activity resuming at site. This revised plan can then be distributed for review and upon approval of the Board, would likely satisfy the Inspectors requirements as identified in the Inspection Report (please note I have not discussed this approach with the Inspector and should be confirmed).

If you require any further information, please do not hesitate to contact me at your convenience. I have also cc'd our Manager of Licensing and one of our technical advisors who will likely be looking after the file (as well as the renewal expected I the new year).

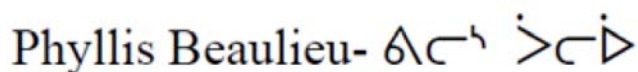
