Introduction

The Nunavut Water Board issued licence NWB1ULU0008 on July 1, 2000 and it will remain valid until June 30, 2008. This Report assesses compliance with the licence for the period between July 1, 2000 and December 31, 2000. The Licence permits the use of up to 100 cubic metres of water per day for ongoing advanced exploration activities at the Ulu Gold Project.

The format of this report follows that of the Licence; however, conditions with no licencee requirements for the year 2000 are not outlined as a compliance assessment does not apply. In addition, several of the Conditions, especially in Part D, are contingent upon activity at the site resuming and are not applicable at this time.
