Re: 2BM-ULU1520 – Bonito Capital Corporation – Ulu Gold Project – Assignment Application - Response to letter dated August 27, 2019 from Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC)

In its letter dated August 27, 2019 CIRNAC indicated that the Minister currently holds \$1,685,210.00 in connection with Water Licence 2BM-ULU1520, which is \$332 less than the total required. This letter is to advise the Board that the Letter of Credit securing this Water Licence was increased by \$332 to \$1,685,542.00 on January 24, 2017. A copy of the amended Letter of Credit is attached.

Having made inquiries with CIRNAC in the last week, it is now our understanding that this increase was not processed by CIRNAC at the time when it was made. To correct this situation we have provided a copy of the amended Letter of Credit to CIRNAC, with original to follow, and Mr. Ian Parsons of CIRNAC has confirmed by email on August 30, 2019 that CIRNAC is presently processing the increase.

We trust that this will not delay the Board's review of our application to assign the above noted licence to Blue Star Gold Corp., as Blue Star has already agreed to post the full amount of the required security.
