Subject: Fwd: Ulu project Letter of Credit

The letter of credit supplied by Societé Generale for Wolfden Resources Inc. in respect of water licence NWB1ULU0008 is dated October 9, 2007 and numbered CT07SOL0038. In the paragraph marked "3(b)(i)", the letter of credit incorrectly identifies the water licence number, it should be licence NWB1ULU0008, and references to two inapplicable land leases should be deleted. The Ulu project is on Inuit Owned Land under the administration of the Kitikmeot Inuit Association. This letter of credit is for water related security as set by the Nunavut Water Board.

Is Wolfden Resources still a registered company and have you requested the Nunavut Water Board to change the name of the water licencee for the two projects to Zinifex Canada Inc.? We are curious since the Letters of

Credit refer to Wolfden Resources Inc. rather that Zinifex Canada Inc. (since the company has had a name change) and are unclear as to the status of each company.

Specifically to the letter of credit:

Recent direction to us has been to change the beneficiary under the letter of credit to read as follows:

Her Majesty the Queen in Right of Canada as represented by the Minister of Indian Affairs and Northern Development

Payable to the Receiver General for Canada

c/o PO Box 100, Building 918

Iqaluit, Nunavut X0A 0H0

Attention: Regional Director General, Nunavut Regional Office

In the first paragraph, where the word "credit" appears in parentheses, the word should be capitalized to be consistent with the usage throughout the letter.

The language in the automatic renewal paragraph is ambiguous, and should be revised as follows: "...shall be deemed to be automatically extended, without amendment, for one year from the present initial expiration date or any and each future expiration date hereof..."
