On February 12, 2015, the Nunavut Water Board (NWB or Board) received from the Kitikmeot Inuit Association (KIA) a request to extend, by two (2) weeks, the comment deadline period set for the public review of the updated Security Assessment submitted by Bonito Capital Corp. for the Ulu Gold Project.

The NWB had received updated Security Assessment on December 31, 2014 and distributed it on January 12, 2015 for a thirty (30) for public comments with the deadline submissions set for February 12, 2015.

Following receipt of the KIA's request, the NWB, through email correspondence, informed Bonito Capital Corp. of the extension request; however, no written confirmation of objection has been received to date.

The NWB has considered the duration of the extension requests and the impact it could have on the renewal process for the Licence, as well as the absence of any written objections from the Licencee with respect to the request, in determining that extension request should be granted.

Interested persons should note that the NWB has hereby granted an extension to the comment deadline period for the updated Security Assessment submitted by Bonito Capital Corp. for the ULU Gold Project. The new deadline for comment from interested parties is **February 27, 2015.**

Parties who have already commented on the document and do not wish to provide additional comments, their current submissions will be considered.
