Corey,

Could you please confirm the intended watersheds for camp activities under your two applications (2WLC-TRP---- and 2WLC-QRP----)? I acknowledge that your camps are not preset, but the polygons on your maps are quite large and might extend out of the watersheds you've listed in your applications.

The Quannituk polygon looks like it might extend across both Back Watershed (No. 31) and Queen Maud Gulf Watershed (No. 30). Your application only indicates Back Watershed (No. 31). Please confirm if your activities will only be in the one watershed or if we should have both in the approval.

The Takijuk polygon looks like it might extend across three watersheds (Coppermine Watershed (No. 28), Coronation Gulf Watershed (No. 29), and Queen Maud Gulf Watershed (No. 30)). Your application indicates you're in the Qikiqtani Region, Queen Maud Gulf Watershed. I'm pretty sure the Qikiqtani statement is a typo. Please confirm if your activities will only be in the one watershed or if we should have two or more in the approval.
