Executive Summary

The Hamlet of Arviat provides water supply, sewage treatment and disposal, and solid waste disposal services for the community.

Nunavut Water Board (NWB) License Number NWB3ARV0308 expired December 31, 2008 and a new license application is in progress.

An Environmental Monitoring Program and Quality Assurance/Quality Control (QA/QC) Plan dated May 2009 was prepared by Nuna Burnside Engineering and Environmental Ltd (Nuna Burnside), as required by the original license and in support of the application for a new license.

As noted in the May 2009 Environmental Monitoring Program and QA/QC Plan, as per the NWB License, the Plan is to be reviewed and updated annually.

This Plan includes recent INAC inspection reports and sampling data.

This May 2010 update of the Plan also addresses comments provided by review agencies during the license renewal application process.

1.0 Introduction

This Environmental Monitoring Program and Quality Assurance/Quality Control Plan for the Hamlet of Arviat, was prepared as a requirement of Nunavut Water Board License NWBARV0308, issued January 2004 and expired December 31, 2008. Although this plan was prepared as a condition of the expired licence, it reflects the current condition of Hamlet facilities, and outlines the Environmental Monitoring Program and Quality Assurance/Quality Control for the new license application currently being submitted.

2.0 Hamlet of Arviat

The Hamlet of Arviat is located within the Kivalliq Region, Nunavut, at general latitude 61°6'N and general longitude 94°3'W (Figure 1). The Community is located approximately 225 km south of Rankin Inlet and 265 km north of Churchill Manitoba.

The topography surrounding the Hamlet of Arviat is relatively flat with a sight rise when moving inland away from Hudson Bay. Local bedrock is generally overlain by glacial fluvial sediments. Arviat is located in the physiographic region of the Hudson Bay lowlands, characterized by low topographic relief, occasional bedrock outcrops and glacial and glacio-fluvial overburden sediments. Boulder fields and eskers are common. Approximately 20 to 30 percent of the land is shallow ponds with depths of 1 m or less. Land between the ponds is marshy, vegetated by grasses and sedges.

The closest climate station to Arviat is the Rankin Inlet Airport Weather Station. The Rankin Inlet area receives an average of 18.1 cm of rainfall and 107 cm of snowfall per annum. Mean annual precipitation totals 29.7 cm per annum. July mean high and low temperatures are 14.9°C and 5.9°C, respectively. January mean high and low temperatures are -28.3°C and -35.5°C, respectively. Winds are generally north-west (Environment Canada, 2008).

The Hamlet provides trucked water and sewage services, along with regular solid waste collection for the residents, businesses and institutions. The water, wastewater, and solid waste systems include the following facilities and services:

- A Water Supply Facility consisting of a water intake pumphouse on Wolf River, two water reservoirs, treatment system and truckfill water station
- Trucked water to holding tanks in each building
- A Sewage Treatment Facility consisting of a sewage lagoon which receives trucked sewage collected from holding tanks in each building and sewage treatment via an exfiltration lagoon to a wetland discharging to the ocean
- A solid waste management facility, which includes a bulky metals area.

The location of these activities is shown in Figure 2.

3.0 Environmental Monitoring and Quality Assurance / Quality Control

3.1 Purpose of Plan

The sewage lagoon and solid waste disposal facilities operated under Nunavut Water Board License NWB3ARV0308 issued on January 9, 2004 and expired December 31, 2008 (Appendix A). The Hamlet is currently applying for renewal of the licence. The license required the Hamlet to conduct a monitoring program, which includes regular water quality sampling and reporting. As required by the license, this Quality Assurance/Quality Control Plan (QA/QC Plan) has been prepared to achieve the following objectives:

- To ensure that all samples taken in the field follow established procedures in order to maintain a high quality, so that the results obtained represent both the physical and chemical nature of the samples being taken
- To ensure best management practices (BMP) are used throughout the sampling program
- To ensure all samples are delivered promptly to an accredited laboratory for analysis.

This document describes the procedures and protocols to be followed when conducting environmental sampling under the monitoring program.

Although the QA/QC Plan is submitted to the Nunavut Water Board (NWB) as a condition of the water license, it is primarily intended to be read, understood, and implemented by Hamlet personnel responsible for environmental quality monitoring. The water license requires Hamlet personnel to adhere to these procedures, which should be applied to all water quality samples taken by the Hamlet.

Quality Assurance (QA) and Quality Control (QC) are vitally important components of environmental management for the Hamlet of Arviat. Contact information for the Hamlet is provided in Appendix B.

3.2 Quality Assurance and Quality Control

Quality Assurance (QA) is a set of operating principles that, if strictly followed during sample collection and analysis, will produce data of known and defensible quality (Wilson, 1995). As such the accuracy of the analytical results can be stated with a high level of confidence. A high level of quality assurance can be achieved by applying the following principles:

- Personnel involved in water sampling and analysis are well trained
- Facilities and equipment required for sampling are suitable, well maintained, and always kept clean
- Standard procedures are developed and implemented for the collection, transportation and analysis of samples, based on recognized best management practices (BMP)
- Laboratory and field instruments are calibrated according to manufacturers recommendations or recognized as good operating practice
- Supplies used in sampling and analysis are of consistent high quality and are not expired
- Quality Control (QC) procedures are developed and implemented based on good operating practices to assess quality of analytical data and provide warning of unacceptable errors
- Remedial action is promptly implemented when deficiencies are identified
- Results of the monitoring program are reported in the Annual Report as required in the water license. The Annual Report must be submitted by March 31 of the year following the calendar year for which the report has been submitted.

Quality Control (QC) is a set of specific procedures used to measure the quality of the data produced and correct deficiencies in the sampling or analyses, as they occur. Quality control is used by the analyst and sampler to achieve standards of measurement for the three principles components of quality: precision, accuracy and reliability.

3.3 Lab Accreditation

All analyses shall be conducted by laboratories that are accredited by the Canadian Association of Environmental Analytical Laboratories (CAEAL) or an alternative accreditation approved by the NWB. A list of CAEAL laboratories is included in Appendix C.

Ideally, the same laboratory will be used for sample analysis each sampling event, to ensure consistency in methodology and reporting. Although all accredited laboratory should be able to provide the same result for a particular sample, some variation is expected, which is why consistent laboratory services are recommended.

Analytical methods and accreditation are usually dictated by the guideline criteria being followed. In most cases, the guideline criteria are the Canadian Environmental Quality Guidelines (CCME, 2007). These guidelines specify bottles, hold times, preservatives, sampling protocols, as well as lab accreditation, and analytical methodologies. Prior to any sampling, this information should be reviewed to ensure consistency with regulation and standards.

4.0 Field Sampling

4.1 Sample Collection

Effluent and surface water sampling by the Hamlet of Arviat is conducted as part of environmental management and to monitor regulatory compliance.

4.1.1 Sampling Location and Frequency

Monitoring Program

The monitoring program included in the water license includes specific requirements regarding sampling locations, sampling frequency and parameters to be analyzed. The following monitoring program has been submitted to the NWB as the proposed requirements for the water licence.

In addition, Environment Canada recommends a Pass/Fail Bioassay Toxicity test prior to effluent discharge to the receiving environment (ARV-2). Toxicity testing provides an evaluation of effluent quality that integrates all measured parameter's and provides an indication of overall effluent characterization with respect to deleteriousness.

The sampling stations will be clearly identified in the field by posted signs. All signs shall be in the Official Languages of Nunavut, and shall be located and maintained to the satisfaction of an Inspector. Each sampling location must have its Global Positioning System (GPS) coordinates determined. This task should be completed prior to the first sampling to be completed under this QA/QC Plan. Samples shall be taken at the same location during each sampling event. Sample locations are shown in Figure 3.

Additional sampling and analysis may be requested by an INAC Inspector or the NWB.

4.1.2 Sample Planning

To understand what sample containers, sampling techniques, and preservation methods are required, the sampler first need to understand what parameters will be analyzed in the laboratory. Table 2 is a summary of possible parameters required, grouped according to their different sampling requirements:

4.1.3 Sample Container Selection

Sample containers vary in size and material of construction depending on the specific type of analysis to be conducted. Sample containers for each analysis are shown in Table 2. Sample containers to be used shall be obtained directly from the laboratory, which shall provide new containers specific for the sampling program. The laboratory will provide the correct sizes and types of bottles based on the parameters required. The laboratory shall be contacted at least one month prior to the sampling event in order to ensure that containers are available for sampling.

See laboratory contact information in Appendix C.

4.1.4 Field Sampling Log

The individual collecting the samples shall record the following at each location at the time of sampling:

- Date of sampling
- Time of sampling
- Weather conditions
- Monitoring Station Number (i.e. ARV-1, ARV-2, etc.)
- Results of any field measurements (temperatures, PH, conductivity, etc.)
- Sampler shall also indicate if sample used preservatives
- Any unusual conditions
- Any deviation from standard procedures.

4.1.5 Field Measurements

No field measurements are required as part of the Hamlet sampling program, however, it is strongly recommended that the following parameters be sampled immediately on site using appropriate portable field equipment:

- pH
- Temperature
- Dissolved oxygen

- Total alkalinity
- Turbidity
- Chlorine residuals.

It is important that separate equipment be used to sample between potable water and non-potable water (i.e. surface water). Furthermore, all instruments, glassware, etc. should be cleaned between each sample following manufacturer's recommended guidelines and/or BMPs.

General Procedures for Sample Collection

General procedures for sample collection are outlined below. Different laboratories have slightly different bottle requirements and sample handling protocols. Sampling technicians must receive site specific training and laboratory procedures must take precedence over other protocols.

- Sample Locations and Sampling Frequency The location and frequency of each sampling option has been carefully selected, and is part of site design and layout, as well as the Water Board License. Sampling will follow their requirements. Diversions must be recorded and submitted to the Water Board for approval
- Preparation Approximately one month prior to the sampling event the laboratory
 will be notified and the required bottles, blanks, and materials assembled. Plans for
 rapid return of the samples prepared
- Field Collection At each sampling station the specified samples will be collected and field data recorded
- Handling Storage and Transportation –Approximate personal protective equipment (gloves, safety glasses, etc.) will be used when handling samples. Samples will be stored a 4°C and protected from freezing until delivered to the laboratory. Chain of custody for sampling, storage, and delivery must be maintained. Laboratory sample sheets will be filled in as per laboratory protocols
- Delivery to Laboratory Samples will be delivered to the laboratory in the laboratory dictated method and within the hold times specified. Preplanning for rapid transport and delivery will usually be required.

Surface Water Sampling Procedures

All of the samples taken will be grab samples. Samples will normally be taken from natural lakes, streams, treatment ponds, or process streams. Where possible, samples

shall be taken from just below the surface to avoid floating debris, which may contaminate the sample.

Freshwater Streams, Surface Drainage, and Wetlands

The samples shall be collected as close to the middle of the stream where water flows freely and is free of debris. Samples shall be collected upstream of the sampler. After getting into position, the sampler shall wait to allow any stirred sediment that occurred from entering the stream to settle or wash away. The sample bottle shall be partially filled with the water to be sampled and rinsed with the lid in place. Rinse water shall be emptied downstream of the sampling point, so that stream sediments remain undisturbed. Prior to sampling for oil/grease, bacteria, and for any bottles containing preservative, the bottles shall not be rinsed.

If possible, bottles shall be plunged into the stream to a depth of approximately half the total stream depth, and allow it to fill with the mouth of the bottle facing upstream. Where stream is too shallow to allow for sample bottle to be filled completely, without disturbing bottom sediment of the streambed, the sampler may use a smaller container that has been properly rinsed to transfer sample to the larger bottle. Do not use a smaller sample bottle containing preservatives.

When taking the sample, sufficient room shall be left to allow for the addition of preservatives, if required.

Lakes or Ponds

Surface sampling shall be collected using the same procedures as streams. Sample bottles shall be plunged to approximately 150 mm (6 inches) below the water surface.

4.1.7 Sample Identification

All samples collected are to be labeled according to standard identification procedures (Name of sampler, time and date of sampling, sample identifier, sampling method and type of sample). Sample labels shall be water-resistant, and prepared prior to going into the field.

The individual samples will be labeled with the following information:

- Sample ID #
- Monitoring Station Name (e.g. ARV-1)
- Date and time of collection
- Parameter to be analyzed
- Preservatives

4.1.8 Sample Preservation

To obtain good results from a sampling program, time is critical. All samples are to be shipped to the Laboratory that has been contracted to carry out the analysis the same day as they are collected. Samples must be protected from breakage, and shall be shipped in an insulated cooler that can be provided by the Laboratory. If samples cannot be shipped until the next day, due to unavoidable events such as weather or mechanical problems with transport aircraft, all samples must be stored in a refrigerator at 4°C. Samples must not be frozen.

In all cases where samples cannot be delivered to the lab on the same day, specific preservatives must be added to the samples to prevent chemical changes that may alter the concentration of the parameters of interest. The samples must be preserved within two hours of sampling. Usually, samples can be preserved away from the field at the end of the site visit. In most cases, the laboratory can fill the bottles with preservative, and then ship them to the Hamlet to be filled and sent back for analysis.

For the Hamlet of Arviat, Table 3 provides the appropriate preservation methods for possible parameters to be assessed.

Table 3: Sample Preservation

Group I Microbiological	Store in refrigerator at 4°C. Ship to Lab the same day as collected

Group III Total Mercury	Acidify with 2 mL of 1:1 sulfuric acid and 5 percent potassium dichromate Store in refrigerator at 4°C. Ship to Lab the same day as collected
Group IV Total Phenols	Acidify with 4 mL of 1:1 sulfuric acid. Store in refrigerator at 4°C. Ship to Lab the same day as collected

4.1.9 Sample Transportation

The main objective of the sampler is to minimize any chemical changes to the sample between the time it is collected and delivery to the laboratory. Heat, light and agitation can all impact the water chemistry and the samples shall be protected from these effects.

Effluent and surface water samples shall be stored and transported at a temperature of 4°C. Coolers and ice packs need to be available and are usually provided by the laboratory. Upon arrival at the laboratory, samples shall be refrigerated as soon as possible.

5.0 Quality Control

Most commercial laboratories undertake QA/QC procedures with the volume of sample sent for analysis. Reports are usually provided with the Certificates of Analysis. It is recommended that the suggested QA/QC protocols by the laboratory be followed.

To ensure that the monitoring program maintains accepted quality control, field blanks and duplicate samples may be suggested by the laboratory. These samples are collected and analyzed for the sample parameters as the monitoring program in the license as part of a quality control check on monitoring activities.

The Field Blanks shall accompany the sampler into the field, labelled as field blanks, preserved in the field and submitted to the laboratory with the field samples.

5.1 Replicate or Duplicate Samples

Replicate or duplicate samples involves collecting more than one sample for a given sampling station subject to specific analysis. Standard procedures used for the routine sampling shall be applied. The replicate or duplicate samples are useful in identifying problems with accuracy and sampling methods.

Once per operating season for each active monitoring station a set of duplicate samples will be taken, representing as many of the routine analysis as possible. Where possible this shall be carried out in conjunction with the sampling undertaken by an INAC Inspector.

6.0 Laboratory Analysis / Reporting

The laboratory will perform the analysis of all samples as outlined herein. The results shall be received by the Hamlet within the time frame agreed to with the laboratory. The results shall contain the limits of detection used for analysis of each parameter as supplied by the laboratory.

The Hamlet may request clarification of the analysis by contacting the NWB Technical Advisor and a review of the analysis will be provided upon request.

The laboratory results are compared to the limits of the Water Licence for each parameter, and/or to other comparative criteria such as the Canadian Environment Water Quality Guidelines. A copy of these guidelines is included in Appendix D.

The results shall be submitted to the NWB for review with the Annual report. A copy of the NWB Annual Report Form is included in Appendix E.

The content of the Annual Report and Guideline Criteria is outlined in the following documents:

- Solid Waste Management Facility Operations and Maintenance Plan
- Sewage Treatment Facility Operations and Maintenance Plan
- Water Supply Facility Operations and Maintenance Plan.

All staff involved in sampling and reporting must have sufficient training to ensure the sampling program operates effectively.

8.0 Glossary

Quality Assurance (QA): is the definitive program for laboratory operation that specifies the measures required to produce defensible data of known precision and accuracy. QA includes quality control and quality assessment activities.

Quality Control (QC): is a set of measures within a sample analysis methodology to assure that the process is in control.

Quality Assessment: is a process to determine the quality of the laboratory measurements through internal and external QC evaluations. It includes performance evaluation samples, laboratory inter-comparisons samples and performance audits.

9.0 Summary

9.1 Overview

This Environmental Monitoring Program and QA/QC Plan has been prepared specifically for the Water Supply Facility, Sewage Treatment Facility, and Solid Waste Management Facility in the Hamlet of Arviat.

Appropriate training for site staff is necessary as part of the implementation of this Plan. This document should be reviewed and updated annually, and whenever the NWB Water License is amended or new relevant legislation is issued.

9.2 Outstanding Issues

As noted in the application documents for a new NWB License, there were historically a number of outstanding issues relating to non-compliance of license conditions regarding monitoring and reporting. A 2008 Annual Monitoring Report was submitted with the license application document, however it lacked many of the required monitoring items.

INAC inspection reports in 2008 (Appendix G) and 2009 (Appendix H) identified a significant number of compliance issues including lack of monitoring and reporting.

The compilation of issues developed from the Technical Meeting/Pre-Hearing Conference also included a number of issues from regulatory agencies related to lack of monitoring and reporting.

It is recommended that the content of this plan and the compilation of issues be included as "Conditions" in the new license with the requirement that they be fulfilled and a report filed by December 31, 2010. It is recognized that some facilities may be out of compliance, and engineering activities may take a longer period of time but the monitoring and reporting should be able to be completed by December 31, 2010, and as per the requirements of the license and this plan, each year there after.






FIGURE 1 - SITE LOCATION MAP



HAMLET OF ARVIAT HAMLET OF ARVIAT, NUNAVUT





After reviewing the submission of the Applicant and written comments expressed by interested parties, the NWB, having given due regard to the facts and circumstances, the merits of the submissions made to it and to the purpose, scope and intent of the Nunavut Land Claims Agreement and of the Nunavut Waters and Nunavut Surface Rights Tribunal Act (NWNSRTA), decided to waive the requirement to hold a public hearing and furthermore to delegate its authority to approve the application to the Chief Administrative Officer pursuant to S. 49(a) of the NWNSRTA and determined that:

I. BACKGROUND

The Hamlet of Arviat is located on the northern shore of a peninsula on the west coast of Hudson Bay. Arviat is located at 61°05' N and 94° 00'W, and is 241 km southwest of Rankin Inlet and 265 air km north of Churchill, Manitoba. The topography of Arviat, which is located on a low and narrow coastal strip, is characterized by low topographic variations, occasional bedrock outcrops and a thick mantle of glacio- fluvial debris. Features include till, fine- grained marine deposits, and extensive beaches. The permafrost is continuous, extending to depths from 30 m to over 100 m. The active layer varies between 0.5 m and 0.3 m. Numerous ponds and lakes are present in the vicinity of the Hamlet, making drainage difficult. The average annual precipitation in Arviat consists of 16 cm of rainfall and 118 cm of snowfall. The mean high in July is 13.1 degrees with a mean low of 4.5 degrees. In January, the mean high is -27.9 degrees and a mean low of -35.0 degrees. The predominant local vegetation consists of mosses and lichens on rocky outcrops, with hardy grasses and sages in swampy and/or more sheltered areas.

II. PROCEDURAL HISTORY

On September 2, 2003, an application for a water licence was filed by the Hamlet of Arviat, which was previously un-licensed by the NWB. The Nunavut Water Board publicly posted notice of this application, in accordance with the Nunavut Waters and Nunavut Surface Rights Tribunal Act S.55.1 and Article 13 of the Nunavut Land Claims Agreement, on October 7, 2003. An assessment of the Hamlet's request for a municipal water licence for water use and waste disposal activities within the Hamlet was then undertaken, so that the Board could make a fully informed decision on the merits of application. This assessment process included the referral of the application to a variety of Federal, Territorial and local organizations for their review and comment. As no public concern was expressed, the NWB waived the requirement to hold a public hearing for the application.

Based upon the results of the detailed assessment, which was completed, including consideration of any potential accidents, malfunctions, or cumulative environmental effects that the overall project might have in the area, the Board delegated to the Chief Administrative Officer authority to approve the application pursuant to S. 13.7.5 of the *Agreement*.

III. ISSUES

Term of the Licence

In accordance with the Nunavut Waters and Nunavut Surface Rights Tribunal Act S. 45, the NWB may issue a licence for a term not exceeding twenty-five years. In determining an appropriate term of a water licence, the Board considers a number of factors, including the results of the annual Department of Indian Affairs and Northern Development (DIAND) site inspection and the

compliance record of the Applicant. Specifically, the August 12, 2002 DIAND Inspection Report indicated:

- 1. The lagoon currently in operation does not have sufficient freeboard, and capacity should be increased;
- 2. Concentrations of ammonia exceeded the levels recommended in the Canadian Guidelines for the Protection of Freshwater Aquatic Life; and
- 3. Levels of Total Suspended Solids and BOD exceeded the Municipal Wastewater Effluent Quality Guidelines.

The NWB has imposed the requirement to produce an Annual Report. These Reports are for the purpose of ensuring that the NWB has an accurate annual update of municipal activities during a calendar year. This information is maintained on the public registry and is available to any interested parties upon request. The Licensee's attention is drawn to the attached standard form for completing the Annual Report (see Attachment I).

The NWB has also imposed on the Licensee the requirement to produce an Operations and Maintenance Manual for their sewage and solid waste operations. The purpose of an Operation and Maintenance Manual is to assist Hamlet staff in the proper operation and maintenance of their waste disposal facilities. The manual should demonstrate to the Nunavut Water Board that the Hamlet is capable of operating and maintaining all waste disposal sites adequately. The Plan should be completed using the Guidelines for the Preparation of an Operations and Maintenance Manual for Sewage and Solid Waste Disposal Facilities in the Northwest Territories (Duong and Kent, 1996; see Attachment II). Additionally, the Plan shall address the operational issues identified at the Sewage Disposal Facility in the July 11, 2002 DIAND Inspection Report

The NWB believes that a term of five (5) years is appropriate, and will allow enough time for the Hamlet to establish a consistent compliance record with the terms and conditions of its licence. It will also ensure that sufficient time is given to permit the Licensee to develop, submit, and implement the plans required under its licence to the satisfaction of the NWB.

Water Use

The Municipality currently receives water from the Wolf Creek water supply located 8.0 km southwest of the Hamlet. Water is stored in a 57,000 m³, 2-cell reservoir located 1.5 km west of the Hamlet, adjacent to the truck fill station. The water receives a chlorine treatment and is then distributed to the community by truck. Water requirements for 2003 were reported as 64,871 m³. Demand for 2008 was not reported in application. Utilizing the water demand formula developed by the Department of Municipal and Community Affairs (Government of the Northwest Territories), projected demand requirements for 2008 was calculated at 78,273 m³.

No concerns were expressed by the parties in their written submissions as to the amount of water required by the Applicant or the manner in which this water will be used. Based upon the projected requirements of the Hamlet, the Board has set the terms and conditions in the water licence, which govern water usage. Accordingly, and based upon the projected requirements of the Hamlet, the Board has set the terms and conditions in the water licence, which govern water usage and which are contained herein. The maximum permitted usage of water by the Hamlet of Arviat, over the term of the water license and for all purposes, has been set at 81,000 m³ per annum.

Deposit of Waste

Sewage

The Hamlet of Arviat utilizes a Sewage Disposal Facility approximately 2.8 km southeast of the Municipality. This Sewage Disposal Facility is located in an area adjacent to the Solid Waste Disposal Facility, and consists of a 55,000 m³ single-cell exfiltration lagoon. The effluent from this lagoon proceeds downstream to the marine environment through an undefined, natural wetland along a 200 m flow path prior to entering Hudson Bay.

Specific comments relevant to sewage disposal operations in the Hamlet were provided by DIAND, and Environment Canada. DIAND and Environment Canada recommended that the Hamlet develop appropriate Operations and Maintenance and Spill Contingency Plans. DIAND and Environment Canada further recommended that the Hamlet take steps to remedy capacity and effluent quality issues currently evidenced at the Sewage Disposal Facility.

Additionally, DIAND provided recommendations concerning effluent discharge criteria, which are consistent with the Guidelines for the Discharge of Treated Municipal Wastewater in the Northwest Territories (Northwest Territories Water Board; 1992), as well as specific recommendations concerning the Monitoring Program. This Program is established to collect data on water quality to assess the effectiveness of treatment for protection of public health and to assess potential impacts to the environment associated with the municipal facilities. The Board concurs with these recommendations, which are reflected in the terms and conditions of the Water Licence. The Board also draws the attention of the Licensee to their requirements to implement the Quality Assurance/Quality Control (QA/QC) Plan to be provided by the NWB. The purpose of the QA/QC Plan is to ensure that samples taken in the field as part of the Monitoring Program will maintain a high quality, so as to accurately represent the physical and chemical nature of the samples being taken. It should also be noted that while minimum sampling requirements have been imposed, additional sampling may be requested by an Inspector.

Solid Waste

The Hamlet's solid waste management site is located adjacent to the Sewage Disposal system, approximately 2.8 km southeast of the community. Waste is segregated, with a generic landfill area,

a bulky wastes area, and an area segregated for hazardous wastes. Combustible wastes are burned regularly, and the landfill is compacted and covered annually.

Recommendations relevant to solid waste disposal operations in the Hamlet were provided by DIAND, DFO and Environment Canada. DIAND and Environment Canada recommended that the Hamlet develop appropriate Operations and Maintenance and Spill Contingency Plans. DIAND further recommended that the Hamlet segregate hazardous materials such as waste oils and batteries from municipal solid waste, and that these materials be disposed of off-site in an approved facility. DIAND, Environment Canada and DFO recommended the appropriate management of waste oil at the solid waste site, so as to prevent the deposition of hydrocarbons into water in contravention of the *Fisheries Act*. The Board concurs with these recommendations, which are reflected in the terms and conditions of the Water Licence.

PART A: SCOPE AND DEFINITIONS

1. Scope

- a. This Licence allows for the use of water and the disposal of waste for municipal undertakings at the Hamlet of Arviat, Nunavut (63°21' N; 90° 42'W);
- b. This Licence is issued subject to the conditions contained herein with respect to the taking of water and the depositing of waste of any type in any waters or in any place under any conditions where such waste or any other waste that results from the deposits of such waste may enter any waters. Whenever new Regulations are made or existing Regulations are amended by the Governor in Council under the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, or other statutes imposing more stringent conditions relating to the quantity or type of waste that may be so deposited or under which any such waste may be so deposited, this Licence shall be deemed, upon promulgation of such Regulations, to be subject to such requirements; and;
- Compliance with the terms and conditions of this Licence does not absolve the Licensee from responsibility for compliance with the requirements of all applicable Federal, Territorial and Municipal legislation.

2. Definitions

In this Licence: NWB3ARV0308

"Act" means the Nunavut Waters and Nunavut Surface Rights Tribunal Act;

"<u>Amendment</u>" means a change to original terms and conditions of this licence requiring correction, addition or deletion of specific terms and conditions of the licence; modifications inconsistent with the terms of the set terms and conditions of the Licence;

"Analyst" means an Analyst designated by the Minister under Section 85 (1) of the Act,

"Appurtenant undertaking" means an undertaking in relation to which a use of waters or a deposit of waste is permitted by a licence issued by the Board;

"Average Concentration" means the arithmetic mean of the last four consecutive analytical results for contained in composite or grab samples collected from the Waste Disposal Facility's final discharge point;

- "Average Concentration For Faecal Coliforms" means the geometric mean of the last four consecutive analytical results for faecal coliforms contained in composite or grab samples collected from the Waste Disposal Facility's final discharge point;
- "Board" means the Nunavut Water Board established under the Nunavut Land Claims Agreement;
- "Chief Administrative Officer" means the Executive Director of the Nunavut Water Board;
- "Commercial Waste Water" means water and associated waste generated by the operation of a commercial enterprise, but does not include toilet wastes or greywater;
- "Composite Sample" means a water or wastewater sample made up of four (4) samples taken at regular periods over a 24 hour period;
- "Effluent" means treated or untreated liquid waste material that is discharged into the environment from a structure such as a settling pond or a treatment plant;
- "Final Discharge Point" means an identifiable discharge point of a Waste Disposal Facility beyond which the Licensee no longer exercises care and control over the quality of the Effluent;
- "Freeboard" means the vertical distance between water line and crest on a dam or dyke's upstream slope;
- "Grab Sample" means a single water or wastewater sample taken at a time and place representative of the total discharge;
- "Greywater" means all liquid wastes from showers, baths, sinks, kitchens and domestic washing facilities, but does not include toilet wastes;
- "Inspector" means an Inspector designated by the Minister under Section 85 (1) of the Act;
- "Licensee" means the holder of this Licence;
- "Modification" means an alteration to a physical work that introduces new structure or eliminates an existing structure and does not alter the purpose or function of the work, but does not include an expansion, and changes to the operating system that are consistent with the terms of this Licence and do not require amendment;

- "Monitoring Program" means a monitoring program established to collect data on surface water and groundwater quality to assess impacts to the freshwater aquatic environment of an appurtenant undertaking;
- "Nunavut Land Claims Agreement" (NLCA) means the "Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada", including its preamble and schedules, and any amendments to that agreement made pursuant to it;
- "Sewage" means all toilet wastes and greywater;
- "Sewage Disposal Facilities" comprises the area and engineered lagoon and decant structures designed to contain and treat sewage as described in the Application for Water Licence filed by the Applicant on September 2, 2003 and illustrated in Drawing # 2003-0440-04/1-3;
- "Solid Waste Disposal Facilities" comprises the area and associated structures designed to contain solid waste as described in the Application for Water Licence filed by the Applicant on September 2, 2003 and illustrated in Drawing # 2003-08-26;
- "Toilet Wastes" means all human excreta and associated products, but does not include greywater;
- "Waste" means, as defined in S.4 of the Act, any substance that, by itself or in combination with other substances found in water, would have the effect of altering the quality of any water to which the substance is added to an extent that is detrimental to its use by people or by any animal, fish or plant, or any water that would have that effect because of the quantity or concentration of the substances contained in it or because it has been treated or changed, by heat or other means;
- "Waste Disposal Facilities" means all facilities designated for the disposal of waste, and includes the Sewage Disposal Facilities and Solid Waste Disposal Facilities, as described in the Application for Water Licence filed by the Applicant on September 2, 2003 and illustrated in Drawing # 2003-0440-04/1-3; and
- "Water Supply Facilities" comprises the area and associated intake infrastructure at the Wolf Creek Water Supply, as described in the Application for Water Licence filed by the Applicant on September 2, 2003 and illustrated in Drawing # 1998-08-24/2.

PART B: GENERAL CONDITIONS

1. The Licensee shall file an Annual Report with the Board not later than March 31st of the year following the calendar year reported which shall contain the following information:

- i. tabular summaries of all data generated under the "Monitoring Program";
- ii. the monthly and annual quantities in cubic metres of fresh water obtained from all sources;
- iii. the monthly and annual quantities in cubic metres of each and all waste discharged;
- iv. a summary of modifications and/or major maintenance work carried out on the Water Supply and Waste Disposal Facilities, including all associated structures and facilities;
- v. a list of unauthorized discharges and summary of follow-up action taken;
- vi. a summary of any abandonment and restoration work completed during the year and an outline of any work anticipated for the next year;
- vii. a summary of any studies, reports and plans (e.g., Operation and Maintenance, Abandonment and Restoration, QA/QC) requested by the Board that relate to waste disposal, water use or reclamation, and a brief description of any future studies planned;
- viii. any other details on water use or waste disposal requested by the Board by November 1st of the year being reported; and
- 2. The Licensee shall comply with the "Monitoring Program" described in this Licence, and any amendments to the "Monitoring Program" as may be made from time to time, pursuant to the conditions of this Licence.
- 3. The "Monitoring Program" and compliance dates specified in the Licence may be modified at the discretion of the Board.
- 4. Meters, devices or other such methods used for measuring the volumes of water used and waste discharged shall be installed, operated and maintained by the Licensee to the satisfaction of an Inspector.
- 5. The Licensee shall, within ninety (90) days after the first visit of the Inspector, post the necessary signs, where possible, to identify the stations of the "Monitoring Program." All signage postings shall be in the Official Languages of Nunavut, and shall be located and maintained to the satisfaction of an Inspector.

- 6. The Licensee shall immediately report to the 24-Hour Spill Report Line (867-920-8130) any spills of Waste, which are reported to or observed by the Licensee, within the municipal boundaries or in the areas of the Water Supply or Waste Disposal Facilities.
- 7. The Licensee shall ensure a copy of this Licence is maintained at the municipal office at all times.

9. The Licensee shall submit one paper copy and one electronic copy of all reports, studies, and plans to the Board. Reports or studies submitted to the Board by the Licensee shall include a detailed executive summary in Inuktitut.

PART C: CONDITIONS APPLYING TO WATER USE

- 1. The Licensee shall obtain all fresh water from the Wolf Creek Water Supply using the Water Supply Facilities or as otherwise approved by the Board.
- 2. The annual quantity of water used for all purposes shall not exceed 81,000 cubic metres.
- 3. The Licensee shall maintain the Water Supply Facilities to the satisfaction of the Inspector.
- 4. The water intake hose used on the water pumps shall be equipped with a screen with a mesh size sufficient to ensure no entrainment of fish.

PART D: CONDITIONS APPLYING TO WASTE DISPOSAL

- 1. The Licensee shall direct all Sewage to the Sewage Disposal Facilities or as otherwise approved by the Board.
- 2. All Effluent discharged from the Sewage Disposal Facilities at Monitoring Program Station ARV-4 shall meet the following effluent quality standards:

- 3. A Freeboard limit of 1.0 metre, or as recommended by a qualified geotechnical engineer and as approved by the Board, shall be maintained at all dams, dykes or structures intended to contain, withhold, divert or retain water or wastes.
- 4. The Licensee shall advise an Inspector at least ten (10) days prior to initiating any decant of the sewage lagoon.

- 5. The Sewage Disposal Facility shall be maintained and operated, to the satisfaction of an Inspector in such a manner as to prevent structural failure.
- 6. The Licensee shall dispose of and contain all solid wastes at the Solid Waste Disposal Facilities or as otherwise approved by the Board.
- 7. The Licensee shall implement measures to ensure hazardous materials and/or leachate from the Solid Waste Disposal Facility does not enter water.
- 8. The Licensee shall submit to the Board for review within six (6) months of the issuance of this license a report identifying each Final Discharge Point. The report shall at least include:
 - a. Plans, specifications and a general description of each Final Discharge Point together with its specific geo-referenced location;
 - b. A description of how each Final Discharge Point is designed and maintained.
- 9. If, during the term of this Licence, additional Final Discharge Points are identified, the Licensee shall submit the information as required by Part D, Item 8 for each new Final Discharge Point within 30 days after the discharge point is identified and at least 60 days prior to depositing Effluent from the new Final Discharge Point and/or proposed changes are made to a Final Discharge Point.

PART E: CONDITIONS APPLYING TO MODIFICATION AND CONSTRUCTION

- 1. The Licensee shall submit to the Board for approval design drawings stamped by a qualified engineer registered in Nunavut prior to the construction of any dams, dykes or structures intended to contain, withhold, divert or retain water or wastes.
- 2. The Licensee may, without written approval from the Board, carry out modifications to the Water Supply and Waste Disposal Facilities provided that such modifications are consistent with the terms of this Licence and the following requirements are met:
 - i. the Licensee has notified the Board in writing of such proposed modifications at least sixty (60) days prior to beginning the modifications;
 - ii. said modifications do not place the Licensee in contravention of the Licence or the *Act*;

- iii. the Board has not, during the sixty (60) days following notification of the proposed modifications, informed the Licensee that review of the proposal will require more than sixty (60) days; and
- iv. the Board has not rejected the proposed modifications.
- 3. Modifications for which all of the conditions referred to in Part E, Item 1, have not been met may be carried out only with written approval from the Board.
- 4. The Licensee shall provide as built plans/drawings of the modifications referred to in this Licence within ninety (90) days of completion of the modifications.

PART F: CONDITIONS APPLYING TO OPERATION AND MAINTENANCE

- 1. The Licensee shall, within 6 months of the issuance of this license, submit to the Board for approval, a Plan for the Operation and Maintenance of the Sewage and Solid Waste Disposal Facilities in accordance with "Guidelines for Preparing an Operation and Maintenance Manual for Sewage and Solid Waste Disposal Facilities" (October 1996). This Plan shall specifically address hazardous waste disposal and operational issues at the Solid Disposal Facility.
- 2. The Licensee shall implement the Plan specified in Part F, Item 1 as and when approved by the Board.
- 3. The Licensee shall revise the Plan referred to in Part F, Item 1, if not acceptable to the Board. The revised Plan shall be submitted to the Board for approval within thirty (30) days of notification of the Board decision
- 4. If, during the period of this Licence, an unauthorized discharge of waste occurs, or if such a discharge is foreseeable, the Licensee shall:
 - i. employ the appropriate contingency plan as provided for in the Operation and Maintenance Plan;
 - ii. report the incident immediately via the 24-Hour Spill Reporting Line at (867) 920-8130 and to an Inspector; and
 - iii. submit to an Inspector a detailed report on each occurrence not later than thirty (30) days after initially reporting the event.
- 5. In the absence of a contingency plan contained within an approved Operation and Maintenance Plan, and should during the period of this Licence an unauthorized discharge of

waste occur, or if such a discharge is foreseeable, the Licensee shall:

- i. take whatever steps are immediately practicable to protect human life, health and the environment:
- ii. without delay seek guidance from the Departments of Community Government and Transportation and Sustainable Development with regards to mitigation and remedial actions required to address the discharge;
- ii. report the incident immediately *via* the 24-Hour Spill Reporting Line at (867) 920-8130 and to an Inspector; and
- iii. submit to an Inspector a detailed report on each occurrence not later than thirty (30) days after initially reporting the event.

PART G: CONDITIONS APPLYING TO ABANDONMENT AND RESTORATION

- 1. The Licensee shall submit to the Board for approval an Abandonment and Restoration Plan at least six (6) months prior to abandoning any facilities and the construction of new facilities to replace existing ones. The Plan shall include, but not be limited to where applicable:
 - i. water intake facilities;
 - ii. the water treatment and waste disposal sites and facilities;
 - iii. petroleum and chemical storage areas;
 - iv. any site affected by waste spills;
 - v. leachate prevention;
 - vi. an implementation schedule;
 - vii. maps delineating all disturbed areas, and site facilities;
 - viii. consideration of altered drainage patterns;
 - ix. type and source of cover materials;
 - x. future area use;
 - xi. hazardous wastes; and
 - xii. a proposal identifying measures by which restoration costs will be financed by the Licensee upon abandonment.
- The Licensee shall implement the plan specified in Part G, Item 1 as and when approved by the Board.
- 3. The Licensee shall revise the Plan referred to in Part G, Item 1 if not approved. The revised Plan shall be submitted to the Board for approval within thirty (30) days of receiving notification of the Board's decision.
- 4. The Licensee shall complete the restoration work within the time schedule specified in the Plan, or as subsequently revised and approved by the Board.

PART H: CONDITIONS APPLYING TO THE MONITORING PROGRAM

1. The Licensee shall maintain Monitoring Stations at the following locations:

Monitoring Station	<u>Description</u>
ARV-1	Raw water supply at the Wolf Creek Water Supply prior to treatment
ARV-2	Effluent discharge from the Final Discharge Point of the Solid Waste Disposal Facilities
ARV-3	Raw Sewage at truck offload point
ARV-4	Effluent discharge from the Final Discharge Point of the Sewage Disposal Facilities

2. The Licensee shall sample monthly at Monitoring Station ARV-2 and ARV-4 during the months of May to August, inclusive. Samples shall be analyzed for the following parameters:

BOD Faecal Coliforms Conductivity Total Suspended Solids Ammonia Nitrogen Nitrate-Nitrite Oil and Grease (visual) Total Phenols Sulphate Potassium Sodium Magnesium Calcium Total Arsenic Total Cadmium Total Copper Total Chromium Total Iron Total Lead Total Mercury Total Nickel **Total Zinc**

- 3. The Licensee shall measure and record in cubic metres the monthly and annual quantities of water pumped from Monitoring Station ARV-1 for all purposes.
- 4. The Licensee shall measure and record in cubic metres the monthly and annual quantities of raw sewage offloaded from trucks at Monitoring Station ARV-3 for all purposes.

- 5. Additional sampling and analysis may be requested by an Inspector.
- 6. The Licensee shall conform to the Quality Assurance/Quality Control (QA/QC) Plan which shall be provided to the Licensee by the NWB within 120 days of the issuance of this license.
- 7. All sampling, sample preservation and analyses shall be conducted in accordance with methods prescribed in the current edition of *Standard Methods for the Examination of Water and Wastewater*, or by such other methods approved by the Board.
- 8. All analyses shall be performed in a Canadian Association of Environmental Analytical Laboratories (CAEAL) Certified Laboratory, or as otherwise approved by an Analyst.
- 9. The Licensee shall measure and record the annual quantities of sewage solids removed from the Sewage Disposal Facility.
- 10. The Licensee shall, unless otherwise requested by an Inspector, include all of the data and information required by the "Monitoring Program" in the Licensee's Annual Report, as required *per* Part B, Item 1.
- 11. Modifications to the Monitoring Program may be made only upon written approval of the Chief Administrative Officer.



The following inspection report was generated on an inspection conducted to determine compliance with the terms and conditions of the water license issued to the Municipality of Arviat by the Nunavut Water Board (NWB). The report references the applicable parts of the current Water License (3BM-ARV0308) and the findings observed under each of those Parts. During the writing of this report a review was undertaken of the documents located on the Nunavut Water Board's FTP site.

The Inspector would like to thank Dave Quksuk, municipal foreman for taking the time to act as a guide and provide input and comments during the Inspection.

Part A: Scope and Definitions

No issues were found with respect to the information contained within the current license issued January 9th, 2004 and scheduled to expire on December 31st 2008.

The license is classed as water use and waste disposal for Municipal Undertakings as indicated on the license form.

Part B: General Conditions

It should be noted that during the period of inspection the Municipality of Arviat was operating under a current water license.

A review of the Nunavut Water Board FTP site, the Inspector failed to find the required annual reports which were to have been filed in accordance with the issued license. The licensee is reminded that the NWB has imposed on the Licensee, the requirement to produce an Annual Report. These reports are for the purpose of ensuring that the NWB has an accurate annual update of municipal activities during a calendar year. A "Standardized Form for Annual Reporting" is to be used by the Licensee and is available from the NWB file transfer protocol (FTP) site under the Public Registry link at the NWB Website.

An annual report is required to be filed by March 31^{st} every year for the previous year ending December 31^{st} . Annual reports are to include the results of the Monitoring Program as outlined in Part H of the current license. As per section 2 of this Part the Licensee is required to comply with the Monitoring program and submit the results of samples collected under the monitoring program.

The Licensee is reminded that any use of water or deposition of waste into any place where it may enter water in Nunavut requires a water license issued pursuant to the Nunavut Water and Nunavut Surface Rights Tribunal Act.

The licensee is reminded that the application process for amendment, modification or renewal may take as long as three to six months. The licensee is strongly encouraged to submit their application as soon as possible to avoid the possibility that they will be forced to operate contrary to the legislation.

Part C: Conditions Applying to Water Use

A visual inspection of the reservoir and intake facilities was conducted during the period of inspection. No issues were noted. Water samples were taken near the intake pipe into the pumping station.

The raw water from Wolf creek is pumped through the pipeline to the reservoir. It is held there until taken up by the pumping station and chlorinated on its way into the water truck. The chlorine residual appears to be measured once daily during the daily inspection.

Metres and records were observed during the inspection inside the pumping station.

It was noted by the Inspector that the Municipality of Arviat does not provide the potable water services within the community. Instead there is a Government of Nunavut, Department of Community and Government Services employee who maintains the system within the community.

Part D: Conditions Applying to Waste Disposal

Sewage treatment;

The Licensee is responsible for ensuring that the effluent discharged from the lagoon system and entering the environment meets the following standards;

Parameter:Max ConcentrationFaecal Coniforms:1X 10(4) CFU/dLBOD80 mg/LTSS100 mg/LOil & GreaseNo visible sheenPHBetween 6 and 9

The licensee is reminded that these parameters are set by the Nunavut Water board and are included in the terms and conditions of the issued water license. Compliance with these terms is an obligation of the Municipality.

The Licensee is reminded that pursuant to section 4 of this Part, prior to a planned decant of the sewage treatment lagoon system there is a requirement for the Municipality to notify the Inspector ten days in advance and to ensure the monitoring program is followed.

Solid Waste Management Area;

It was noted during the period of Inspection that the Municipal burn and bury area had not been incinerated in a prolonged period of time and was close to capacity. Mr. Quksuk stated that the wind had been blowing toward town for the last month thus preventing the burning of materials.

The bulk metals area showed signs of segregation activities taking place. No secondary containment was noted however barrels and other hazardous materials were consolidated to one end of the facility.

The Licensee is reminded that pursuant to section 8 and 9 of this part a report on the identification of each and every final discharge point for where effluent or any leachates from the waste management facilities enters the environment or water is managed by the licensee.



Part E: Conditions Applying to Modifications and Construction

Section 1 of this Part reads as follows;

1. The Licensee shall submit to the Board for written approval, construction design drawings stamped by a qualified engineer registered in Nunavut, prior to the construction of any dams, dykes or structures intended to contain, withhold, divert or retain water or wastes.

Again a review of the Nunavut Water Board FTP site could not find an application or approval for the stream diversion as noted during the period of Inspection.

Part F: Conditions Applying to Operations and Maintenance

The Water Intake pump house and community reservoir were found well maintained and in good working order.

The Licensee was unable to produce a Sewage and Solid Waste Disposal Operations and Maintenance manual during the period of inspection. The Licensee is reminded that pursuant to Section 1 of this Part, the Licensee was required within six months of the issuance of the current license, to submit an Operation and Maintenance Manual for the Sewage the Solid Waste Disposal Facilities prepared in accordance with the "Guidelines for Preparing an Operation and Maintenance Manual for Sewage and Solid Waste Disposal Facilities", October 1996. This document was not found during the same review of the Nunavut Water Board FTP site.

The licensee should be aware that in line with the current standards the following plans will be required for submission under the authority of any renewal license;

- a. Water Facility Operation and Maintenance (O&M) Plan;
- b. Sewage Disposal Facility Operation and Maintenance (O&M) Plan;
- c. Sewage Sludge Management Plan;
- d. Solid Waste Disposal Facility Operation and Maintenance (O&M) Plan;
- e. Spill Contingency Plan; and
- f. Monitoring Program Quality Assurance/Quality Control Plan (QA/QC Plan).

The above plans all forming part of the overall Operation and Maintenance manual required under the license.

Part: G Conditions Applying to Abandonment and Restoration

The Licensee was unable to produce an Abandonment and Restoration Plan during the period of inspection. During the consolidation of this report a review of the Nunavut Water Board FTP site was not able to locate a plan.

Part H: Conditions Applying to the Surveillance Network Program (Monitoring Program)

The licensee is reminded that they must ensure that adequate signage is in place.

During the inspection it was noted that the Hamlet had not complied with Section 2 of this Part. The Licensee is reminded that they must collect the required samples at two locations (ARV-4 and ARV-2)

during the months of May through August and have these samples analyzed for the following parameters, as outlined in the current license;

Fecal Coliforms

Ammonia Nitrogen
Nitrate-Nitrite
Sulphate
Calcium
Potassium
Total Cadmium
Total Chromium
Total Zinc
Total Lead

These samples are to be collected and analysed in accordance with a Quality Control / Quality Assurance plan. There is no indication that this was completed by the Licensee at any time over the duration of the current license.

Samples were collected during the period of Inspection at the reservoir, 50 meters downstream of the bulk waste facility and 50 meters from the Lagoon. Results from the samples are as follows;

Issues with a known or anticipated human health impacts;

- o Sewage treatment in the community continues to be below an acceptable standard.
- o Collect and submit for analysis the samples required on the Monitoring Program.

Issues where there is a known or anticipated environmental impairment;

- Undertake such works as required to prevent erosion of the lagoon system into waters downstream of the lagoon system.
- Undertake such water management as is required to control the spread of runoff from the waste management area into the wetlands area below the lagoon system.

Issues where there is a known or suspected violation of a requirement of the Water License;

- O Implement the requirements listed under the Monitoring Program.
- O Develop and submit an Operation and Maintenance Manual, and associated plans.
- Submit as required all Annual Reports including the results of sampling under the monitoring program.
- O Submit the required abandonment and restoration plan.
- O Provide clarification on the roles and responsibilities of the licensee and the Government of Nunavut in relation to Potable water treatment and delivery in the community.
- o Install and maintain the appropriate signage, and Surveillance Network Program (SNP) markers.
- o Develop a Quality Assurance/ Quality Control Plan (contact the Nunavut Water Board).

The Municipality of Arviat continues to operate in Non-conformity with those terms and conditions of the Water License issued in 2004.







The following inspection report was generated on an inspection conducted to determine compliance with the terms and conditions of the water license (expired) issued to the Municipality of Arviat by the Nunavut Water Board (NWB).

The report references the applicable parts of the current Water License (3BM- ARV0308) and the findings observed under each of those Parts. During the writing of this report a review was undertaken of the documents located on the Nunavut Water Board's FTP site.

It is noted that on January 5th, 2009 the Nunavut Water Board received an application from the Licensee for a Type A water license for the community.

The Inspector would like to thank Mr. Ed Murphy, the acting hamlet foreman during the period of the Inspection, for taking the time to meet and accompany the Inspector during the Inspection.

N.B: It was noted by the Inspector that the Municipality of Arviat does not provide the potable water services within the community. Instead there is a Government of Nunavut, Department of Community and Government Services employee who maintains the system within the community. The Inspector calls on the board to provide clarification as to why the Municipality has this service included within the scope of the issued license. If the Government of Nunavut is responsible for the operations and maintenance of the Potable Water delivery service and infrastructure a license should, as past practice would dictate, be issued in the name of the Government of Nunavut.

Previous findings:

The community of Arviat's water license (3BM-ARV0308) expired on December 31st, 2008. An application for renewal for the expired Type B license was submitted by Nuna Burnside, on behalf of the Hamlet of Arviat.

The application was found to be incomplete by the Nunavut Water Board and a request for missing information was sent out on May 15th, 2009. Additionally is was noted by the Nunavut Water Board that as per the information provided in the application the required license now falls into a Type A category and that would be how the Board would be proceeding on the file. The file is currently being held by the board pending the submission of the required information to enable them to proceed with the application.

Currently the Hamlet of Arviat is unlicensed.

Issues noted in previous Inspections;

- o Sewage treatment in the community is below an acceptable standard.
- o Failure to collect and submit for analysis samples as required under the Monitoring Program.
- Failure to undertake such works as directed to prevent the continued erosion of the lagoon system into waters downstream.
- o Failure to undertake such works as required for control of the spread of runoff from the waste management area into the wetlands area below the lagoon system.
- O Failure to develop and submit an Operation and Maintenance Manual, as associated plans.
- O Failure to submit as required all annual reports (it is noted a 2008 Annual report was submitted).
- O Failure to submit the required abandonment and restoration plan.
- O Failure to provide clarification on the roles and responsibilities of the licensee and the government of Nunavut in relation to Potable water treatment and delivery in the community.
- o Failure to develop and submit a Quality Assurance/ Quality Control Plan.

During the period of the 2009 Inspection the following issues were identified by the Inspector;

- o Failure to file a complete 2008 annual report. (report was found to be incomplete)
- o Failure to take steps to prevent and control the migration off site of runoff from the Solid Waste Management Facility.
- o Failure to comply with the monitoring program by collecting samples for analysis.
- o Failure to undertake such works as is required to restore/ remediate the two currently abandoned Sewage lagoons.
- o Failure to address the continued seepage and release of contact water from the old and now abandoned lagoons.

Samples collected from water outside but adjacent to the lagoon by the Inspector returned the following results;

(It was noted by the Inspector that the samples collected outside the lagoon had an obvious odour of sewage however samples did not arrive at the lab within the required time limit for testing for fecal coliform colonies.

Samples collected from water from Bulk Metals Waste Management Area by the Inspector returned the following results;

Issues with a known or anticipated human health impacts;

- Failure to address concerns identified by the Inspector regarding effluent leaking from the Sewage Lagoon.
- Failure to address concerns identified by the Inspector concerning Water Management within the Waste Management areas.
- o Failure to collect and submit for analysis the samples required on the Monitoring Program.

Issues where there is a known or anticipated environmental impairment;

- o Failure to take steps to control and mitigate runoff from the Solid Waste Management Facility.
- o Failure to develop a Solid Waste Disposal Operations and Maintenance Manual.

Issues where there is a known or suspected violation of a requirement of the Water License;

- o Failure to submit required Annual reports. (Part B (1 i through viii)) (it is noted that an Annual report for 2008 was submitted with the renewal application to the Nunavut Water Board and was found to be incomplete)
- o Failure to maintain the appropriate Surveillance Network Program. (SNP)(Part B (5))
- o Failure to notify the Inspector prior to decant as required. (Part D(4))
- o Failure to identify and submit the Final discharge points for the current lagoon system. (Part D (8))
- Failure to submit as required documents and drawings properly certified of the "new lagoon" as required under (Part E (4)).
- o Failure to submit as required the appropriate Abandonment and Restoration Plans. (Part G (1))
- o Failure to implement the requirements listed under the Monitoring Program. (Part H)
- o Failure to development and submit a QA/QC Plan. Part H (6))
- o Failure to Maintain the Sewage lagoon to the satisfaction of the inspector. (Part D(5))

The Municipality of Arviat continues to operate in Non-conformity with those terms and conditions of the Water License issued in 2003 and now expired. The licensee and the Government of Nunavut are strongly encouraged to contact the Nunavut Water Board and the Inspector to determine next steps as are required to achieve and maintain compliance with a license and the Act.
