The Nunavut Water Board acknowledges receipt of supplemental information for the Hamlet of Arviat water licence renewal and amendment application. The timeline of processing the application is as follows

- September 17, 2020, the NWB distributed the renewal amendment application for Water Licence No: 3AM-ARV1016 completeness check;
- November 20, 2020, the NWB deferred further review process on the recommendation from ECCC;
- April 19, 2021, the Applicant requested to pause the renewal amendment application process for Water Licence No: 3AM-ARV1016 in order to undergo screening by the Nunavut Impact Review Board for additional activities in the scope of the application;
- November 19, 2021, supplemental information received

The completeness check of the application is now resumed and comments are due December 1, 2021. The application can be found at the link below:

The NWB notes that ECCC advised in its submission:

"In the responses to the Completeness Check comments, the Hamlet identified that the feasibility studies for the upgrades to the solid waste facility and sewage lagoon facility have been delayed and will be provided in January 2021. In addition, the Hamlet identified that a number of updated plans will be provided in March 2021. In the absence of this information, no new technical information has been presented as part of this water licence renewal and amendment. ECCC recommends deferring technical review until such time that these plans and studies are made available for review."

The NWB finds ECCC's recommendation to be reasonable and will defer the review until such time that the outstanding submissions are received by the Board.
