Dear Mr. Johnston:

Further to the recent correspondence of the Nunavut Water Board (NWB or Board) regarding the Technical Meeting and Pre-Hearing Conference in relation to the Application described above to take place on <u>Tuesday March 30, 2010 and Wednesday March 31, 2010</u> at the <u>Hamlet of Arviat's Community Hall</u>, the NWB notes that three parties have indicated they will be unable to attend the Technical Meeting and Pre-Hearing Conference in person. Although the NWB has canvassed rescheduling options with the other parties to accommodate these scheduling challenges, recognizing the importance of promoting public awareness and participation in respect of the Application, the NWB has been unable to find alternate suitable dates for the Technical Meeting and Pre-Hearing Conference. Consequently, the NWB proposes to proceed as planned with the in-person meeting to be held in the community, with the parties unable to attend in person being able to attend via teleconference.

Please find attached the proposed Agenda for the Technical Meeting and Pre-Hearing Conference. As part of this Agenda the NWB will hold a community session on the evening of March 30, 2010 to allow residents of Arviat to express any concerns about the water licence application and to ask any questions of the parties. To facilitate the community session, the NWB invites the Hamlet of Arviat or its representative, the Government of Nunavut Community Government Services, to begin the community session with a presentation to the community describing the project as well as any water and waste related issues.

By copy of this letter, the Board is asking interested parties to provide comments on the proposed Agenda and to confirm their attendance at the Technical Meeting and Pre-Hearing Conference, including the planned community session, by <u>March 25, 2010</u>.
