Hello Major Allard,

I don't know what the status of whether or not Landing Lake, with its salt content, is being used at all. I've copied Wayne Thistle

(GN-C&GS/Rankin) and Jim Rogers (INAC/Iqaluit) as they may be able to assist with more direct reports.

In normal times, the actual raw freshwater source is drawn from a large river, located about 5-6 km SW of the community. There is a pipe (about 8" diameter, plastic), lying along the surface of the terrain that carries the water to the two artificial reservoirs constructed just west of town (seen in the images). The pipe runs approximately in a SW direction from the reservoirs to the river source where there is a large water pump housed. My understanding is that once a year (in the summer months, when all is thawed) the pump is turned on to replenish both reservoirs.

On the corrosive concerns for equipment, Wayne may have some first-hand knowledge of what issues have been raised.
