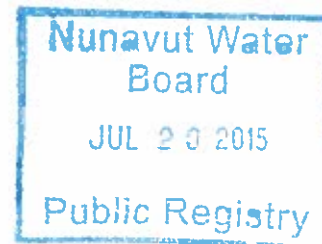
Thank you for your letter of June 17, 2015, conveying the short-term renewal of type A water licence 3AM-ARV1016 for the Hamlet of Arviat.
