The following works and activities have been proposed in the above-noted project proposal:

1. The Municipality of Chesterfield Inlet has updated its water use to reflect the daily amount of water pumped during the resupply period, rather than the daily amount of treated water consumed throughout the year.
2. Associated NPC File No: 149870
3. Location: Kivalliq Region; Chesterfield Inlet, within the Municipal Boundaries

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. The activities associated with this proposal were previously reviewed by NPC, and a conformity determination was issued on April 28, 2015 and October 27, 2022 which still applies. In addition, the activities were previously exempted by the Nunavut Impact Review Board (NIRB File No.: EX232). It conforms to the Keewatin Regional Land Use Plan (KRLUP). The proponent has undertaken to comply with the applicable conformity requirements of Appendix C, G, and H of the KRLUP.

This project proposal is exempt from the *Nunavut Planning and Project Assessment Act* (NUPPAA) under section 235 of that Act. The above-noted project proposal does not require screening because the NPC is of the understanding that it does not change the general scope of the original or previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply.
