Good afternoon,

For Compliance History, the inspector identified the exfiltration as a leak which we believe may have been a misunderstanding. The lagoon was constructed as permeable and therefore effluent should be expected to move through the berm wall during the open water season. Based on all the previous wetland reports and accompanying recommendations, the wastewater treatment is to be attributed to the wetland not the lagoon.

For Waste Disposal, run-off from the solid waste disposal facility has not been confirmed to be mixing with sewage effluent.
