Hello,

In their initial response to recommendations ECCC-2 and ECCC-3, the licensee states "The QA/QC Plan will be updated to reflect this recommendation". As this response was written as a commitment to update the QA/QC Plan, ECCC considered those recommendations resolved.

In the Commitments List attached, the No. 2 commitment corresponding to ECCC-2 and ECCC-3 reads "Review revisions suggested by ECCC over the summer of 2022 and provide updated QA/QC".

For ECCC-3, the Commitment List should be updated to reflect the original commitment, as it was the basis for resolving the recommendation.

The licensee could review and trial the recommendation outlined in ECCC-2, however, if after the trial they decide not to adopt the recommendation, then sufficient rationale would need to be provided to justify that decision.
