Michele,

Hi! My name is Dave Baines. I'm the Technical Advisor at the Nunavut Water Board that has been working on the Amendment Application by Rankin Inlet to relocate the intake of their water plant. While I have only recently joined the NWB, I am aware that this file has considerable history and this desire to move the intake is no surprise to anyone.

I'm very sorry to hear that they have been experiencing high levels of turbidity. That can certainly present challenges to water treatment plants. None of us want to see the health of any community at risk.

For the record, NWB is neither for or against the relocation. At this time we don't have a complete application to amend the Licence. Once we have a complete application, the typical time frame for an amendment to this type of licence is 9 months (including a public hearing). I did ask Megan Lusty to discuss that potential problem with me back in February of this year. So far, that has not been discussed in a meaningful way and additional information for the application has not been provided.

The NWB would be happy to chat with you or others to see what could be done in this situation.
