Hi Karen,

At the time I provided my comments/questions in September, our Fisheries Protection (Habitat) Program was run a bit different than it is now. Since that time, all new projects are now triaged by DFO's Burlington Office as per the below:

For all occurrence reports, or project proposals where you have determined, following self-assessment, that you cannot avoid

impacts to fish and fish habitat, please submit to fisheriesprotection@dfo-mpo.gc.ca. For general inquiries you can also call 1 855 852-8320.

I can only assume our Burlington office reviewed any updates/changes to the Rankin Inlet water supply project since my September review, and if no comments were provided – perhaps there was nothing further to add, or perhaps DFO will not be involved in this project. Distribution

Fisheries and Oceans (DFO) Iqaluit Office received copy of the Aug.23, 2013 request from NWB (below) today. Due to the delay in receipt, unfortunately I have not yet been able to review in any detail the documents uploaded onto NWB's registry specific to this Amendment.

That being said, in an effort to keep within the due date, DFO does have a few questions for clarification, and should an extension be granted for detailed comment, more technical questions can be provided.

Questions as follows:

- -Was an alternatives assessment completed for the proposed new water source?
- -Was an evaluation of fish and fish habitat in Char River and waterbodies upstream and downstream conducted?
- -Does the Proponent have information to conclude that fish and fish habitat will or will not be affected by the proposed new intake in all seasons (spring, summer, fall, winter)
- -Assuming pumping will be occurring year round, has the Proponent considered impacts to fish and fish habitat during low flow periods, and will there be sufficient flow?
- -Has the Proponent proposed any mitigation measures to protection fish and fish habitat from the intake including construction and design of the intake, velocity, screen size and type, location, etc?
- -Does the Proponent have a preliminary design of the proposed intake that can be provided?
- -Will dredging be required to facilitate construction and placement of the intake? And if so, how often will maintenance dredging be required?
- -Will the proposed pipeline be required to cross any other watercourses/waterbodies?

-Has any consultation taken place with respect to potential impact to fishing in Char River, and if so, what comments have been received, and were they considered in the proposal?

-As there is a fish habitat compensation project which is currently being monitored upstream constructed by Agnico-Eagle for the Meliadine Mine Project, has consideration been given towards any potential impact to the Agnico compensation project as a result of potential lower water levels resulting from the intake?

Elizabeth/Karen,

My understanding for this file is that it has previously received comments by Liz. As such the Triage team considered it to be an existing project that already had started DFO review. DFO Triage does not review works that have previously been assigned an assessor or have received comments by another DFO biologist regardless if there are changes to the works. This is in effort to provide consistency within a review.

Hope this clarifies any confusion.

As Liz mentioned previously, DFO does have a streamlined review process. As per the DFO website, if proponents can follow self-assessment guidance and follow measures to avoid harm, DFO has no concerns with proposed works. The following criteria applies to water taking:

Water Extraction

- Surface water extraction for commercial bottling, drinking and sanitary, industrial use, thermal/nuclear generation, agricultural irrigation and other uses
 - There is no reduction in the width of nearby waterbodies
- Groundwater extraction for commercial bottling, drinking and sanitary, industrial use, thermal/nuclear generation, agricultural irrigation and other uses
 - No change to baseflow of nearby waterbodies
 - No change to the thermal regime of nearby waterbodies
 - No change to groundwater upwelling locations and volumes in nearby waterbodies

Additional information is provided on the website pertaining to screening of intakes etc.
