## **Technical Review Memorandum**

Type "A" Water License Renewal Application – Completeness and Re: Initial Technical Review of Type "A" 3AM – GRA1015 - Hamlet of Rankin Inlet

## **Comments/Recommendations**

- 1) Given that the Hamlet of Rankin Inlet is not applying for more water use, water use currently set at 850,000m<sup>3</sup>, and has indicated that they will have to apply for a licence amendment in 2023 for an increase in water use, as well as there being a lot of uncertainty in regards to Char river being a sustainable water source to resupply Nipissar Lake for a number of years, AANDC is not in support of a 25 year water licence renewal for the Hamlet of Rankin Inlet and would rather support a 8 year term to 2023.
- 2) AANDC also notes that First Landing Lake or Lower Landing Lake was used and may still be used for industrial purposes (float planes, etc). AANDC has learned that because of these past industrial uses there is a possibility of hydrocarbon contamination within the lake itself and also within the catchment area. AANDC recommends that the applicant clearly demonstrate that there is no contamination within the catchment area of Char River.
- 3) AANDC notes there are missing or incomplete administrative reports including annual (monitoring data for all years) and quarterly reports for this water licence since the renewal n 2010. AANDC recommends that the Hamlet provide the missing information or justification as to why it has not been submitted to the NWB.
- 4) AANDC notes that the applicant has indicated that they will be pumping water from Char River to supplement Nipissar Lake at a rate of 3485m<sup>3</sup>/day. However AANDC would like more information as to how many days the applicant requires, what the minimum/maximum number of days that pumping will occur. Will the number of pumping days increase in subsequent years or will the pumping rate increase to account for more water use per year.
- AANDC would also like further information on the sustainability of Char River and subsequent contingency plans. If for example the applicant is only able to withdraw water from Char river for 5-7 days this year, what will be the





plan going forward? Will the applicant look immediately for a different secondary source or will they wait another year or two to see if other years provide more pumping days.

- 6) AANDC notes that there is no alternative's assessment for additional water sources should Char River not be sufficient as a supplemental water source. AANDC recommends that the applicant provide an alternative's assessment of other water sources which could be utilized as a supplemental water source for Nipissar Lake.
- 7) AANDC notes that there are still many non-compliance issues outstanding in regards to the water licence (i.e., Water Quality Monitoring). These noncompliance issues will be further commented on in detail at the technical review stage of the water licence process.
- 8) AANDC notes that the applicant plans on submitting updated versions of the following plans;
  - Updated Sewage Treatment Facility Operation and Maintenance (O&M) a. Plan; and
  - b. Updated Environmental Monitoring Program and Quality Assurance/Quality Control Plan.

AANDC notes that there has been problems with the sewage disposal system in the past and looks forward to reviewing these plans when they are made available.

- 9) AANDC also notes that the applicant also plans on submitting a *Water* Pumping Adaptive Management Plan as per Part C, Item 11 of Amendment No.1. AANDC also looks forward to reviewing this plan when it is made available.
