The 2024 Annual Report states that "Updated O&M Plans for the new water supply facilities will be provided in the 2026 Annual Report for the Board's review." As per the modification letter issued by the Board on April 03, 2025, the Licensee is required to submit the O&M plans for the new Water Treatment Plant within 90 days after construction, along with the Spill Contingency Plan.
