**RE:** Licence No. 3AM-GRA1624 – Modification No.1

Dear Ms. Lusty:

The Nunavut Water Board (the NWB or Board) has completed its review of the proposed modification to the existing water supply facilities in Rankin Inlet submitted to the Board on May 6, 2016 by Government of Nunavut, Community and Government Services (GN-CGS or Licensee) as per Part E, Item 2 of the Licence No. 3AM-GRA1624 (Licence), issued for the Hamlet of Rankin Inlet Municipal Undertaking in the Kivalliq Region, Nunavut. The Licensee indicated in its submission that "the water storage tank adjacent to the Williamson Lake Pumphouse will be converted from a raw water storage tank to a treated water storage tank in summer 2016, in order to achieve the required chlorine contact time outlined in the Public Water Supply Regulations of the Public Health Act".

The review determined that the proposed activities as identified in the request do not constitute significant changes to that already permitted under the Licence and do not impact the water source, volume or use. Therefore, with issuance of this correspondence, the Licensee is authorized to undertake the modifications as proposed in its request. The Licensee should note, however, that if the scope of activities under the requested modification were to change, following issuance of this letter, it is the responsibility of the Licensee to inform the Board to

ensure that all relevant activities are considered.

The Licensee is advised that Part E, Item 5 of the Licence requires that as-built plans and drawings of the construction and/or modifications referred to in Part E of the Licence No. 3AM-GRA1624 be provided to the Board within ninety (90) days of completion of the Construction or Modification.

The Licensee is also advised that in accordance with the relevant terms and condition included in Licence, details pertaining to the activities conducted under the authorized modification (Modification No.1) must be included within the annual report submitted to satisfy the requirements of Part B, Item 1 of the Licence.

## Part B, Item 11 of Licence states:

The Licensee shall review the Plans referred to in this Licence as required by changes in operation and/or technology and modify the Plans or Manuals accordingly. Revisions to the Plans or Manuals are to be submitted in the form of an Addendum to be included with the Annual Report required by Part B, Item 1(g), complete with a revisions list detailing where significant content changes are made.

Therefore, the Licensee is required to submit within the next 2016 Annual Report updates to the approved Water Supply Facility Operation and Maintenance (O&M) Plan to include changes associated with the Modification No.1.
