- iv. A summary of modifications and/or major maintenance work carried out on the Water Supply and Waste Disposal Facilities, including all associated structures and facilities;

Three Capital Projects on Water supply, Wastewater treatment and Solid waste management were started in this community. Solid waste project is totally on hold. Final Design of the Sewage lagoon is complete by EXP Services Inc., but this is also on hold until further order due to funding. The design of the Water Truck fill station is complete by Arktis solution Inc. Development of Tender package is in progress. A fence has been purchased and delivered to the community, and will be installed around the water reservoir at the pumping station.

Once the new solid waste management facility is built and commissioned, the existing site will be abandoned and restored. No abandonment and restoration work was conducted during this reporting year.

- vii. A summary of any studies requested by the Board that relate to waste disposal, water use or reclamation, and a brief description of any future studies planned;

The studies on solid waste management was completed recently by Arktis solutions Inc. New guidelines have been developed and accepted by GN. The project is on hold due to funding. A bathymetric survey on south water lake was conducted by also Arktis Solution Inc.

Current waste management, wastewater treatment and water supply system are the concerns of the Nunavut Water Board.

The new O&M manuals will be prepared for Water supply, wastewater treatment and waste management site once they are built and commissioned. No update or revision was made on the O&M manual for any licensed facilities during this reporting period.

Hamlet started extended sampling and testing program already. We are planning to segregate waste this summer. We are also planning to implement the CGS report card this year to closely monitor and maintain environmental facilities.

- xi. **FOLLOW-UP REGARDING INSPECTION/COMPLIANCE CONCERNS:**

Hamlet is working with CGS for AANDC inspection concerns and Water Licence Compliancy. They are working closely with CGS to renew the water licence.
